Rabies vaccinations will be offered for **\$6.00**. **Canine and feline vaccinations/boosters will also be available.** Dogs' must have a current rabies vaccination prior to licensing for **2013/2014**.

To expedite waiting time, please bring last year's license receipt. If corrections need to be made to your dog license application form, please advise staff at the time of licensing.

Intact Dog License Fee: \$20.00

Altered Dog License Fee: \$10.00
(Certificate required for new dogs)

☺ Mammoth Lakes, Inyo County and Nevada residents are welcome to take advantage of the low cost vaccination clinics but are reminded that they need to purchase dog licenses in their own jurisdiction.

important: For the protection of your cat, other cats, family and the community, we strongly urge that all cats be given rabies vaccinations as well as other feline vaccinations needed for their health and protection.

A \$20.00 LATE FEE WILL BE CHARGED TO EACH LICENSE POSTMARKED AFTER JUNE 30TH

*If paying by check at a clinic - please be advised that two checks will be required: One check to the applicable attending Veterinarian Hospital and the second check to Mono County for dog licenses.

To best serve each community, we adhere to a rigid schedule in order to arrive at each clinic in a timely manner, please arrive no later than 30 minutes prior to clinic closing.

For Everyone's Safety;

If you have a dog that may be aggressive towards humans or other dogs, or hard to handle, please leave him/her in your vehicle until all paperwork is completed. The attending Veterinarian will go to your vehicle to administer vaccinations.

Prior to standing in line for service, we ask that you have your cat safely secured inside a cat carrier.

Please secure your dog on a leash while waiting to be served.

In order to avoid injury to yourself, your cat, other folks in line, or to avoid having a frightened cat run away from you..... Mono County Animal Control is pleased to have cat carriers available for your use at each clinic - please ask personnel for assistance.

DOG AND CAT OWNERS :

TO ENSURE A SAFE AND SPEEDY RETURN SHOULD YOUR DOG OR CAT BECOME LOST – MONO COUNTY ANIMAL CONTROL HIGHLY RECOMMENDS THAT YOU CALL YOUR VETERINARIAN TO ASK FOR INFORMATION REGARDING MICRO-CHIPPING.

Title 17 –Ca. Code of Regulations 2696.04© Officially Declared Rabies Areas. “States that any agency with a fixed one year licensing program cannot license a dog if the: **three year rabies vaccination expires before the expiration of the 2013/2014 license”.**

If your dogs' rabies vaccination falls in this category, please have your dog re-vaccinated at a low cost vaccination clinic or with your family veterinarian prior to licensing.

Health and Safety Code 1920 (b), Mono County Code 9.20.010 – All dogs over the age of 4 months shall be vaccinated for rabies at prescribed intervals. **(This includes all yard, lap, house, cattle/ranch/show and commercially kenneled dogs).**

Health and Safety Code 1920 (a), Mono County Code 9.12.060 - All dogs over the age of 4 months shall have and wear a current Mono County dog license.
