### INSTRUCTIONS TO VOTERS

To vote for a candidate whose name appears on the ballot, CONNECT THE HEAD AND TAIL OF THE ARROW WHICH POINTS to the right of the candidate's name. Where two or more candidates for the same office are to be elected, CONNECT THE HEAD AND THE TAIL OF THE ARROW WHICH POINTS to the right of the names of all candidates for the office for whom you desire to vote, not to exceed, however, the number of candidates to be elected.

To vote for a qualified WRITE-IN candidate, write in the person's name in the blank space provided for that purpose after the names of the other candidates for the same office and CONNECT THE HEAD AND TAIL OF THE ARROW WHICH POINTS to the right of the name you have written in, or your vote will not be counted.

To vote on any measure, CONNECT THE HEAD AND TAIL OF THE ARROW WHICH POINTS to the word "YES" or the word "NO."

**REVIEW YOUR BALLOT:** Mark your ballot completely

- If you vote for more candidates than allowed, or if you vote both Yes and No on a measure, it is called an overvote. Your vote will not count for that candidate or measure.
- You do not have to vote on all contests. Those you do vote on will still count. This is called undervoting.

If you make a mistake, wrongly mark, tear, or deface any portion of your ballot, return it to the Precinct Board Member and obtain another ballot.

AFTER YOU HAVE COMPLETED VOTING, retain the numbered stub and deposit your voted ballot into the ballot box.



CONNECT THE HEAD AND TAIL of the arrow that points to your choice.


**IMPORTANT:**

For each office, except voter nominated offices, write-in spaces follow the list of candidates.


Write the person's name in the space provided for each office. Then use the marker provided to connect the head and tail of the arrow that points to your choice.



# IMPORTANT INFORMATION ABOUT VOTE BY MAIL

## MAKING YOUR VOTE COUNT

Vote by Mail Ballots are rejected when the signature on the return envelope does not substantially match the signature on your voter registration card.



If you cannot remember how you signed your original registration card, or if your signature has changed, re-register so your current signature will be on file. Get a Voter Registration Card at:

## CALIFORNIA ELECTIONS CODE

**3017.** (a) All vote by mail ballots cast under this division shall be voted on or before the day of the election. After marking the ballot, the vote by mail voter shall do either of the following: (1) return the ballot by mail or in person to the elections official from whom it came or (2) return the ballot in person to a member of a precinct board at a polling place within the jurisdiction. However, a vote by mail voter who is unable to return the ballot may designate his or her spouse, child, parent, grandparent, grandchild, brother, sister, or a person residing in the same household as the vote by mail voter to return the ballot to the elections official from whom it came or to the precinct board at a polling place within the jurisdiction. The ballot must, however, be received by either the elections official from whom it came or the precinct board before the close of the polls on election day.

**3206.** A voter whose name appears on the permanent vote by mail voter list shall remain on the list and shall be mailed a vote by mail ballot for each election conducted within the precinct in which he or she is eligible to vote. If the voter fails to return an executed vote by mail ballot in four consecutive statewide general elections in accordance with Section 3017, the voter's name shall be deleted from the list.

## **VOTE-BY-MAIL: OPTIONS FOR RETURNING YOUR BALLOT**

In order for your vote to count, your ballot 1) must be received no later than 8:00 p.m. on Election Day (postmark won't suffice); 2) must be in the Vote-by-Mail return envelope; and 3) return envelope must be signed. Return options:

- Mail your voted ballot as soon as possible prior to the election. ***Ensure correct postage is on your return envelope; check with the post office.***
- Return your voted ballot in person, sealed in the envelope provided, to the County Elections Official (County Clerk-Recorder-Registrar) or one of her deputies at either of the following offices:
  - Main office in Bridgeport (County Clerk's Office, 74 School Street, Annex I), Monday-Friday, 8:00 a.m. to 5:00 p.m.; on Election Day 8:00 a.m. to 8:00 p.m.
  - Satellite location at County Offices in Mammoth Lakes, 437 Old Mammoth Road Suite P (2<sup>nd</sup> floor Minaret Village Mall above Giovanni's Pizzeria), prior to Election Day, Monday-Friday, 8:00 a.m. to 5:00 p.m.
- On Election Day, return your voted ballot in person (sealed in the envelope provided) to an elections official at any Mono County polling place, prior to close of polls at 8:00 p.m.

A vote-by-mail voter who is unable to return their ballot in person, may designate his or her spouse, child, parent, grandparent, grandchild, brother, sister, or a person residing in the same household as the vote-by-mail voter to return their ballot. **Remember, your ballot must be in the Vote-by-Mail return envelope and you must sign the return envelope. ***Please Review this Important Information***

## **ACCESSIBLE POLLING PLACES**

The Mono County Elections Office makes every effort to secure polling places that are accessible to the elderly and to voters with disabilities. If an asterisk (\*) follows the designation of your polling place on the back cover of this booklet, it is an accessible polling place. If you are unable to access your polling place, a precinct officer can bring a ballot to you at a place which is accessible, as near to the polling place as possible. In addition, all voters are entitled to Permanent Vote-by-Mail status. If you wish to claim Permanent Vote-by-Mail status, check the appropriate box on the Vote-by-Mail Ballot Application on the back cover of this booklet, and return it to the Mono County Elections Office.

★**NEW:** You may now request a vote-by-mail ballot via telephone. Call 760-932-5537.

**For this election, an application or request must be received by the Elections Office no later than 5:00 p.m. on May 27, 2014 (postmark will not suffice).**

## **OPEN PRIMARY ACT OF 2010 (aka Top-Two Candidates)**

The Top-Two Candidates Open Primary Act was created and implemented by the June 2010 passage of Proposition 14. Except for the office of U.S. President and county central committee offices, offices that were known as “partisan offices” (state constitutional offices, congressional, and state legislative offices) are now known as **voter-nominated offices**. What was known as a “political party affiliation” is now known as a “political party preference.”

All candidates for the voter-nominated offices in the June 3, 2014, Primary Election will be listed on your ballot regardless of party preference. All voters, regardless of party preference (or lack of party preference) may vote for any candidate for a voter-nominated office. A candidate from the Primary Election will only advance to the General Election in November if he or she is one of the top two vote-getters.

## **PROVISIONAL VOTING AT POLLING PLACE**

The provisional voting process is available to assist voters whose eligibility to vote cannot be determined at the polling place. Provisional voters will be given instructions for voting at the polling place. Reasons for provisional voting:

- The voter's name is not listed on the Roster of Voters.
- The voter has moved within the County but did not re-register to vote.
- The voter's name is listed on the Roster of Voters as having received a vote-by-mail ballot but, for whatever reason, is unable to surrender the ballot.
- The voter is listed on the Roster of Voters as a First Time Federal Election Voter and is required to show proof of identification, but is unable to show proof.

## **VOTE-BY-MAIL PRECINCTS**

If you reside in a vote-by-mail only precinct, you are not assigned to a polling place and you will receive your Official Ballot through the mail. You should receive your ballot approximately three weeks before the election. If not, please contact the Mono County Elections Office **immediately** by calling 760-932-5537.

To vote for a qualified write-in candidate, write the person's name on the blank line provided and CONNECT THE ARROW.

**IMPORTANT:** Use only a pencil or a black/dark blue ink pen.

**DO NOT USE RED INK OR FELT TIP PEN**

If you make a mistake marking your ballot, return it to the Election Official and a replacement ballot will be issued.

### VOTER-NOMINATED AND NONPARTISAN OFFICES

All voters, regardless of the party preference they disclosed upon registration, or refusal to disclose a party preference, may vote for any candidate for a voter-nominated or nonpartisan office. The party preference, if any, designated by a candidate for a voter-nominated office is selected by the candidate and is shown for the information of the voters only. It does not imply that the candidate is nominated or endorsed by the party or that the party approves of the candidate. The party preference, if any, of a candidate for a nonpartisan office does not appear on the ballot.

**STATEMENT OF CANDIDATE FOR  
U.S. REPRESENTATIVE, 8TH DISTRICT**

**PAUL COOK**

**Occupation:** United States Representative

**Education and Qualifications:** Two years ago, as a retired Colonel with 26 years of service in the US Marine Corps, I asked for your trust to become your Congressman. Having been awarded the Bronze Star and two Purple Hearts for my time in Vietnam, I witnessed great sacrifices by my fellow Americans and pledged to ensure their efforts would not be in vain.

As your Congressman, I've honored that commitment by fighting for a balanced budget, for our veterans, to keep jobs in America, and to defend our way of life.

I fought to pass a balanced budget plan to reduce the deficit by \$4.6 trillion over the next ten years, strengthen America's economy, and protect Medicare for seniors. I voted over ten times to defund, delay, and replace Obamacare.

I fought to restore the Cost of Living Adjustment for all veterans and for the in-state college tuition rate they deserve. I supported the Keystone pipeline because it would put 20,000 Americans to work.

In Mono County, I've worked to ensure that public lands are used for the public good. I've authored legislation to help our ski resorts stay open and create new local jobs, and I'm fighting attempts by the federal government to monopolize even more land.

Voters may return only their own voted vote by mail ballots, in person or by mail, to the Registrar's Office or at any polling place in the county, to be received no later than the close of the polls on Election Day. However, a vote by mail voter who is unable to return the ballot, may designate his or her spouse, child, parent, grandparent, grandchild, brother, sister or a person residing in the same household as the vote by mail voter, to return the ballot to the election official from whom it came or to the precinct board at a polling place within the jurisdiction. EC3017.

**NOTICE TO THE PHYSICALLY HANDICAPPED VOTER**

If the polling place is not designated as accessible to the physically handicapped voter, such voter may request a vote by mail ballot by completing the application on reverse side, or a precinct board member shall take a regular ballot to the physically handicapped person at a place as near as possible to the polling place and which is accessible to such person, qualify that person to vote and return the voted ballot to the polling place. (California Elections Code Section 14282.)

**PERMANENT VOTE BY MAIL VOTER STATUS**

State law now allows any voter who so requests to be a Permanent Vote by Mail Voter. If you check the Permanent Vote by Mail Voter box on the Application for a Vote by Mail Ballot on reverse side, a vote by mail ballot will automatically be sent to you for future elections. Failure to vote in four consecutive statewide general elections will cancel your Permanent Vote by Mail Voter Status and you will need to reapply.
