## WHAT THIS MEANS...

- COVID-19 transmission is accelerating rapidly in Mono County with epicenter continuing to be in Mammoth Lakes
- Less data for unincorporated areas due to less testing and health care access but cases have doubled for Northern Mono County in last 2 days (from 2 to 4)
- Earned a place on CDPH Monitoring List which comes with additional countywide sector restrictions/rollbacks focused on indoor activities
- Closure of personal services including hair cutting and tattoos
  - Closure of gyms
  - Religious services to be outdoor only
  - Additional efforts and actions necessary in Town of Mammoth Lakes
- Anticipate more transmission (spread) throughout Mono County

Applies to all restaurants within the Town of Mammoth Lakes

- Personal Protective Equipment (PPE)
  - All restaurant employees must wear higher level, more protective face coverings at all times while at work:
    - Surgical masks
    - N-95s
  - Eye protection recommended for employees (already required for dishwashers)

- Mono County Public Health to provide free testing:
  - Wednesday 7/22
  - Thursday 7/23
  - Friday 7/24
- Responsibility of each restaurant to schedule employees

- Sick employees must be excluded from work until cleared by Mono County Public Health or a licensed clinician

    - Names and total number of employees
    - Names and dates of tested employees
- Failure by a restaurant to self-attest by midnight 7/28 shall result in immediate closure until attestation is completed

# STATE RELEASE GUIDANCE REQUIRING CALIFORNIANS TO WEAR FACE COVERINGS IN MOST SETTINGS OUTSIDE THE HOME

- On June 18, the California Department of Public Health (CDPH) issued guidance mandating the use of cloth face coverings by the general public when outside the home (with exceptions).
- Mono County Public Health Officer Dr. Tom Boo previously issued a similar Order within Mono County on May 1, 2020.
- Enforcement: "We will seek to educate and gain voluntary compliance. Those who are aggressively uncooperative will be charged with the appropriate criminal violation."

COVID-19 Positive Patient Hospitalized at Mammoth Hospital

Mammoth Hospital has hospitalized its first patient since late March due to COVID-19. While the Eastern Sierra has seen relatively few infections over the last few months, the pandemic continues to be a threat to Mono County. This patient is now hospitalized and being treated for coronavirus.



"This new hospitalization is a reminder that the pandemic is still a very real crisis, on both a local and global level," says Mammoth Hospital CEO, Tom Parker. "Many restrictions have been eased and we have seen a reopening of many businesses, giving us a sense of normalcy. Mono County's 'Stay Safe to Stay Open' campaign speaks to the need to stay vigilant in our efforts to cover, distance and wash. We have seen a significant increase in the last two weeks in the number of people testing positive for COVID-19. This is not the time to let our guard down. Mammoth Hospital has taken great steps to prepare for a surge of COVID patients, and we remain prepared to care for anyone who presents to our facility."

### STATE OF CALIFORNIA ATTESTATION CRITERIA

- Demonstrated stable/decreasing number of patients hospitalized for COVID-19 by a 7-day average of daily percent change in the total number of hospitalized confirmed COVID-19 patients of hospitalized confirmed COVID-19 patients of <+5%</li>
  -OR- no more than 20 total confirmed COVID-19 patients hospitalized on any single day over the past 14 days.
- 14-day cumulative COVID-19 positive incidence of <25 per 100,000 – OR – testing positivity over the past 7 days of <8%.</li>

# STATE MONITORING LIST

### For counties on Monitoring List for 3 consecutive days

- Industries open statewide
- Casinos
- Hotels (for tourism and individual travel)
- Campgrounds and outdoor recreation

The following industries must close indoor operations, but they may be modified to operate outside or by pick-up:

- Dine-in restaurants
- Wineries and tasting rooms
- Movie theaters
- Family entertainment centers (for example: bowling alleys, miniature golf, batting cages and arcades)
- Zoos and museums
- Cardrooms
- Hair salons and barbershops
- Gyms and fitness centers
- Personal care services, like nail salons, body waxing and tattoo parlors
- Places of worship and cultural ceremonies, like weddings and funerals
- Offices for non-critical infrastructure sectors
- Shopping malls
