I am writing to you today to express my opposition to this Proposed Development, namely the Tioga Inn Project. On many fronts, it should be denied/withdrawn from further considerations. It is a disaster waiting to happen.

My first visit to Mono Lake and Lee Vining was in the early 1960's. Since that time, very little has changed in Lee Vining and the surrounding areas, which attributes to the attractiveness of Mono County. A small, quaint resort community in a very unique, pristine and awesome location which takes you to another place and time without the hustle and bustle that are so typical of some larger resort communities. This proposed development will encourage these aspects to be common place of those larger resort communities. The Tioga Inn project undoubtedly will generate more noise and air pollution; and, it will certainly impact many public services to the community more than two-fold. Traffic will increase, the demand for public services will increase (i.e. hospitals, emergency services – fire and law enforcement, utilities, etc.) and can the area actually accommodate these services without further development taking place? This proposed Tioga Inn development will undoubtedly open the door to permit similar future construction projects in Lee Vining. Ultimately, any major developments of this type will severely change the perspective on the quaint resort community atmosphere of Lee Vining and Mono Lake.

As this project *may* get underway, migratory birds and wildlife in general will be threatened by the environmental changes that will occur -- it will alter their frequency and survival in this part of Mono County. Dear Honorable Supervisors,

Thank you for this opportunity to comment on the proposed amendment to the Tioga Inn Specific Plan. Mammoth Lakes Housing, Inc. (MLH) is a regional nonprofit community housing development organization (501c3) serving Inyo, Mono, and Alpine counties. Our organization has expertise in housing development, state/federal grants, and housing program development and services such as emergency rental assistance and first-time homebuyer loans.

On Thursday, June 25, 2020 the MLH Board of Directors held a special meeting at which they discussed the proposed amendment to the Tioga Inn Specific Plan. We have the following recommendations:

- We believe that it could be clearer that the project is intended to be rented at rates that will be affordable to project employees and area residents. Affordability is critical so that our community members are not spending a disproportionate amount of their income on housing expenses (no more than 30% is the Federal standard), becoming cost-burdened and therefore unable to afford other necessities such as clothing, food, medicine, etc.
- 2) Additionally, the Board feels that providing housing for those employees generated by the hotel and restaurant components of the Specific Plan that they can afford is critical to reducing vehicle-miles travelled and corresponding pollution in Mono County.
- 3) We commend the property owner for including community housing in the Specific Plan amendment. We suggest that the owner partner with Mono County and other relevant organizations to seek grant funding to ensure that the housing is affordable to our residents in the long-term.
- 4) Lastly, the Board wanted to address the negative stigma often associated with workforce/community/affordable housing. Some of the public comments have mentioned additional "screening" for the housing project. While preserving the

natural environment is important, it is our hope that this community housing project will be a place that residents are proud to call home and Mono County is proud to showcase as an affordable, safe place for our friends, neighbors, and workforce to live. We do not recommend any amendments to the project that would derail, delay, or unreasonably increase the project costs.

Dear Honorable Supervisors,

I am once again writing to comment on the Tioga Inn Project, this time specifically on the final Project analysis (FSEIR).

I am both a home owner and small business owner in the Mono Basin (specifically Mono City) and have lived here since 2002. My husband has lived here since the mid-1980s. Despite the fact that in many ways our lives would be much easier were we to move to Bishop (most of my work is down there, medical care, errands, etc.), we LOVE living here. We love the community and the *wild undeveloped* nature of the Mono Basin.

I have to say this is one of the more difficult comment letters I have ever written -- there are so many unknowns in the Project, that trying to address implicit rather than explicit possible outcomes is making my head spin:

- 1. After 27 years of an approved hotel/restaurant facility still not built, the developer is proposing to build workforce housing for staff. Why do we believe after 27 years that the hotel/restaurant will ever be built? What if, extrapolating from the recent past, it is never built?
- 2. We know that gateways to National Parks are popular locations for wealthy second home owners. If the hotel/restaurant is never built, how do we know the developed housing won't simply be sold to wealthy second home owners, significantly altering the character of our local community. We know what that looks like -- all one has to do is visit Mammoth Lakes or the communities surrounding Lake Tahoe. Even after all these years, I am still surprised when I visit either of those location, at the number of empty units!
- If the restaurant/hotel is in fact built, will said hotel/restaurant staff even be able to afford to live there in the proposed housing? My income is considerably better than a hotel/restaurant worker, yet I would struggle to afford Eastern Sierra market rate. (NOTE: I do understand that 3% of the units will be affordable housing; it's the other 97% I am concerned about).
- 4. If the hotel/restaurant is built, and the staff can in fact afford to live in the proposed housing units, who will subsume the inevitable additional costs and strains on the community of Lee Vining, which will potentially quadruple in population size. NOTE: this is in fact, a rhetorical question; as the Project is currently laid out, the developer does not mitigate any additional costs, so it will fall to the Mono County tax payers. Besides all of the above unknowns, here's what we do know:
  - 1. We are a tourist based economy and the big draw, besides being a gateway to Yosemite, is the undeveloped nature of the Mono Basin. Like most locals, I have a large amount of visitors in the summers, and even some in the winters. My friends and family love visitin, and contribute to our local gas, food and lodging economy. Additionally, I am friendly and end up chatting with many tourists. Invariably, *everyone* comments on how fortunate we are to live in such a wild undeveloped place. A facility of the magnitude of the Tioga Inn housing units will have a huge, forever, visual impact on the wild undeveloped character.
  - 2. The project will be visible, with potential glass glare and illumination, from South Tufa, the most visited tourist attraction in Mono County. I take everyone who visits me to South Tufa!
  - 3. I am so happy to be in the 80% of Americans who can actually see the Milky Way. We know that a facility of this magnitude will adversely affect our dark night skies.
  - 4. The intersection of highways 395 and 120 is already dangerous. This development will only increase the vehicular danger.
  - 5. If in fact the housing is filled with workforce and their families, pedestrian traffic will inevitably increase between the Tioga Inn housing and "downtown" Lee Vining. I walked it once with a few small children. I was on edge the whole time, and cannot imagine ever doing it again.
  - 6. This sets a horrible precedent for local communities working with the county. What is the point of doing a Community Plan -- a plan that many members of the community spent a lot of time and thought developing -- only to have it overridden by one developer.

I, and many others in the community, recognize housing is a big issue in Mono County in general, as well as specifically within the Mono Basin. To be clear, I do not have an "I got mine" attitude. There has been local community effort to address this issue. Rather than a questionable solution (does the Tioga Inn Project solve the housing issue, or rather does it simply introduce more problems?) essentially rammed down our throats, I would prefer to see a continuation of the local effort to create consensus around a solution.

Finally, due to the sheer magnitude of this project, both in terms of its scale and its essentially "forever" duration, it will have an enormous impact on the essential character of Lee Vining and the Mono Basin. I find it hard to believe a decision with so many unknown possible outcomes can justifiably be made given the magnitude of its impact.

On June 29 the Board will be asked to vote on a resolution to override the concerns of local Agencies, residents, and the public in order to approve the Tioga Inn Project - <u>which violates the Mono Basin Community Plan Vision and Principles</u> - and accept its significant adverse impacts on the Mono Basin.

The final Project analysis shows it will create significant adverse impacts to local schools, the volunteer fire department, the safety of pedestrians and cyclists, traffic safety, the local deer herd and the visual integrity of Mono Lake and the gateway to Yosemite National Park.

The Project has raised widespread alarm by agencies such as the Volunteer Fire Department, Eastern Sierra Unified School District, and the County Sheriff.

A yes vote on the override resolution will offload millions of dollars of unfunded obligations onto the community and taxpayers who will have to provide the development with expanded County services.

The Board should not override citizens and local agencies and accept permanent significant adverse impacts on our community. We all share a desire to provide affordable housing for our community members but this Project is not the solution.

The Project must not be approved as proposed. If the Board determines that fixing the Project is worthwhile, require the Developer to work with the community to accomplish a redesign that mitigates significant impacts and aligns with the vision and values of the Mono Basin Community Plan.

Dear Supervisors Corless, Stump, Peters, Gardner and Kreitz:

Three times in the past 20 years, we considered relocating to Mono County when job opportunities were enticing. Before moving, we looked at Mono County's underlying structural problems, such as inadequate tax base, the undependable tourist economy and weak housing infrastructure and ultimately passed on the jobs as too risky. But we still love Mono County and sympathize with your struggle to address these challenges. My current work includes analysis of planning projects and potential community benefits.

When there are significant environmental impacts, in order to declare a statement of "over-riding necessity," the governing body must declare some sort of community benefit. What will Mono County and Lee Vining gain? It seems to me that **this projects fails the test of a specific economic, legal, social, technological or other benefit.** Property tax is not enough.

#### What community benefits did you negotiate?

## 1. How will this apartment complex serve as a community benefit to the workforce of Mono County? It does not appear to solve Lee Vining's housing problem.

"Employer assisted housing" allows the employer to restrict units to employees. School districts and hospitals have used this strategy. "Affordable housing" restricts rentals to tenants to those who have specified income. They can come from anywhere; they don't have to be local or employees of the hotel or restaurant. "Market rate" does not restrict tenancy at all.

• The proposed apartment project is 95% market rate even though the Tioga Inn Specific Plan of 1993 calls for a hotel and restaurant. Those maid, waitress, and retail jobs will be seasonal and mostly minimum wage. They will not be able to afford this apartment housing. <u>Where will the minimum wage workers live? Will they still be</u> <u>commuting from Bridgeport, Bishop, or camping in the National Forest? For whom is this project intended?</u>

• Under Fair Housing Laws, "Employer Assisted Housing" can be restricted to <u>employees</u>. However, this project calls for Phase 1 to house construction workers of the hotel who are not employees of the hotel but of the contractor. <u>Does the Fair Housing law allow the interpretation of employee to be stretched for a contractor's employees?</u>

• The planning staff report suggests that residents could work at Mammoth in the winter season. Yet, Fair Housing Laws require that people who stop working for the employer for more than a specified period must be removed from the "Employer Assisted Housing." Yet the staff report comments on how this housing will provide stability in housing. This suggests there is no plan for this apartment complex to be restricted to the employees of the hotel, restaurant, gas station and mini-market. Then who will be renting these market rate units? How will tenants be selected? Is the apartment complex for employees of the hotel and restaurant or for non-employees who could be from anywhere?

• The property owner has indicated a plan to sell the hotel and restaurant entitlements/development plans. Then there would be no legal employee/employee relationship between the apartments and the hotel/restaurant. **Under Fair Housing laws,** <u>this apartment project must be open for rental to ANYONE with the ability to pay.</u> Wealthy technology folks from the San Francisco Bay Area or beyond will be able to rent. What a beautiful view

they will enjoy. <u>How will this apartment complex with no restrictions solve Mono County's workforce housing</u> <u>shortage? How will it not exacerbate the workforce housing shortage?</u>

# 2. How will the project provide a community benefit to the Eastern Sierra Union School District and its students?

• The financial analysis within the staff report indicates that the increase in property tax from the apartments, hotel, and restaurant will not cover the cost of forecasted staffing needs. Developer fees will pay for the portable classroom. Forecasted enrollment numbers indicate that Lee Vining school will increase their student:teacher ratio beyond state guidelines.

### 3. How will the project provide a community benefit for Lee Vining's tourist industry?

• Lee Vining's tourist industry is comprised of two populations—those who come for Mono Lake and its wildlife, and those who drive through town to go to Yosemite. The people who come for Mono Lake are going to notice the impacts of the apartment complex, and the hotel and restaurant. Some will be offended. Those who came for Mono Lake's Dark Sky will be angered and will head elsewhere for their next trip. Bird people will notice the light impacts. Deer people will fret over the impacts on the deer. Those who drive to Yosemite will note the commercialization. Ever since the Tioga Inn was constructed, the gas station, restaurant and stores were all impacted as many tourists didn't bother to travel into Lee Vining. The Tioga inn cannibalized business. **How will local businesses benefit from the apartment complex**?

### 4. What other economic benefit might result after the apartment building is built?

Although the apartment project is supposed to provide housing for construction workers for the hotel, what is the likelihood it will be built? The restaurant and hotel have been approved for nearly 30 years. The late 1990s was a boom time, and they didn't get it financed before the dot com crash. There was recovery and financing available between 2003 and 2008, and it didn't happen. There was some financing available from 2012 to 2018 and nothing. Now, COVID19 is here and there are huge impacts to the tourist industry. Lots of solo travelers are likely but no more busloads. What's the likelihood that any other economic benefit will occur from the Tioga Inn Specific Plan? I'm not holding my breath.

### 4. How will this apartment project provide a community benefit to improve the traveler's experience?

The apartment project will generate significant traffic impacts at the driveway for Highway 120. Consider the current Friday and Saturday traffic jams and fender benders. How often are the CHP and LV Volunteer Fire Department called out? It seems to me that I see something every summer weekend that I've been in town. Where's the data? Where are the traffic improvements? Where is the agreement to put someone on Highway 120 to control the ingress/egress at those peak periods for these apartment dwellers, such as going to school, or commuting to work at Mammoth?

# 5. How will the apartment project provide a community benefit for the traffic safety for pedestrians walking to Lee Vining?

Yes, Caltrans didn't follow through on building the improvements along Highway 395 from Highway 120 to Lee Vining. Yes, the overpass over Highway 120 has much more work must be done and the FinalSEIR doesn't guarantee the project will go forward, but why not ask for. Why not ask for funding for staff time to seek grant funding or legal time to negotiate a project completion from Caltrans and an easement from SCE? A three times per day shuttle is not sustainable.

### 5. What community benefit is guaranteed in the open space?

The staff report comments that open space is increase with this revision, but the net gain is only 0.7 acres. While there is more "Open Space Preserve," how is this guaranteed. Since 1993 this is the FOURTH revision to the plan.

The open space preserve could disappear on any given Monday with a vote of the supervisors. For what reason did Mono County not demand a conservation easement on the open space preserve?

# 6. What community benefit will be provided to compensate for the increased death rate of Lee Vining canyon deer herd?

Mitigation included suggest that there will be some reduction in deaths, but there will still be some deaths along Highway 395 as they are funneled through a narrower migration route. What will this project due to help with the health of the herd? Or the numbers? Or the safety of the driver along Highway 395? Or the hunter who wants a successful hunt from this Casa Diablo herd? The herd is much smaller than the 1960s and 1970s. What will this develop do to help?

#### SUMMARY

This project doesn't provide the community benefits that would make it worthwhile for the county to find overriding considerations to ignore the significant environmental impacts. This is a market-rate complex that can turn into tourist housing. Mono County needs permanent, deed-restricted affordable housing.

# RE: Tioga Inn project concerns from the Lee Vining Fire Protection District

Dear Supervisors,

First, thank you for taking the bold step to hold an in-person meeting to consider this proposed project. A project with as large and complex as this should require thoughtful, honest and unhurried discussion and consideration.

Founded in 1947, the Lee Vining Fire Protection District provides fire and BLS medical first response to the community of Lee Vining and adjacent public lands and communities. We are a small district staffed by approximately 12 volunteer fire fighters, two certificated EMTs, and operating on a budget of approximately \$60,000 per year. On average, the Department responds to 70 calls per year; half of these calls are requests for medical assistance with the remaining half split between traffic accidents and fire response.

The District is not in a place to oppose or support the proposed project, but the elected Commissioners of the District feel strongly that the District's previous concern regarding this project be strongly reiterated in the hopes of protecting the public, our firefighters and the integrity of our small, rural volunteer department.

In particular, we request your help in addressing two outstanding items of concern:

- 1. Protection of Public Pedestrian Safety; and
- 2. Emergency Access Road.

# Protect Public Safety Through Meaningful Mitigation

The District strongly implores the Board of Supervisors to protect public safety by rejecting the current FSEIR's conclusion that "exposure of pedestrians & cyclists to unsafe travel conditions between the Tioga site and Lee Vining" and "impacts associated with turning movements from eastbound SR 120 onto northbound US 395", while "significant" are "unavoidable."

While we agree these impacts to public safety are "significant," they are not "unavoidable."

From our standpoint, public safety should not be willing sacrificed when very meaningful and achievable mitigations are possible.

In the case of pedestrian and cyclist safety, the Board should **require Mitigation SCVS 5.8 be amended to include planning, construction and maintenance of a connection to the existing sidewalk network in Lee Vining.** As written this public safety mitigation does not address the problem but only requests reservation of a right-of-way for a sidewalk while shoving the burden for completing and maintaining this critical safety infrastructure to the taxpayer rather than the project proponent. The reality of the threat to public safety posed by creating a new, privately owned city housing upwards of 300 people outside of the existing community of Lee Vining is clearly established in the FSEIR and supported by fellow public safety agencies.

The current 'shuttle' mitigation at DSVCS 5.8(a-3) represent a similar half-measure as this 'shuttle' would only be required to be in service if and when the long-planned hotel receives an occupancy permit. What about the families who are supposed to occupy the workforce housing? Given the current phasing proposed in the document, this 'shuttle' mitigation protects no one until the entire, nearly three-decades old project is completed.

As people who live with a State highway as their main town street, we live the threat and outcome of high-speed traffic near pedestrians every day. You have the ability to affect real protection for future generations of families and tourists by requiring this project protect public safety by connecting itself to town from the start.

Following a similar strategy of accepting that "project impacts on the US 395/SR 120 intersection during mid-day conditions for the forecast opening year of 2023 [as] significant, adverse and unavoidable," rather than pursue meaningful mitigations to protect public safety the FSEIR simply "deleted" "all traffic mitigation measures outlined in the DSEIR."

We are troubled by this notion of 'giving up' when presented with direct, fully mitigatable impacts to public safety presented by the increased traffic congestion created by this complex project. Very real traffic mitigations, such as the installation of a traffic circle at the intersection of 120 and 395 or other engineerable and proven traffic calming measures, must be included in any acceptance of this project.

# **Require a Secondary Emergency Access Road**

As currently proposed, the proponent is 'voluntarily' obtaining an easement to a one-lane, dirt SCE road connecting to Highway 120W approximately 1/2 mile uphill from the project site. While we support a secondary emergency access road as part of this project, we request that this critical public safety infrastructure be required to be fully deeded prior to any granting of grading or construction permits.

Additionally, we believe a required emergency access road should provide a real alternative route out of the project. Given past fire behavior in the area has driven east, downhill, from higher up in the canyon toward the project, we are concerned an access road that leads into the direction of probable fire does not address the issue. Rather than a voluntary route heading up canyon, the District requests an emergency access route providing an escape route to the east onto Highway 395 be included as a required project mitigation.

In conclusion, we see no justification for willingly accepting significant threats to public safety when there are measures that can be taken. The Lee Vining Fire Protection District respectfully requests you use your ability to help improve this project for the proponent, our community and the public by requiring real, meaningful and achievable mitigations that will protect public safety.

I visit Mono Lake and stay in Lee Vining yearly, for at least one week, in July or August. I am very concerned about how the Tioga Inn Project will affect the visual appearance and views in the gorgeous area.

## My main concerns about the Tioga Inn project as presented in the Draft SEIR are the following:

• The project's visual impacts are significant, and the proponent has not considered sufficient mitigation to screen the Tioga Inn Workforce Housing Village.

• The Final SEIR needs to include project alternatives that reduce the visual and aesthetic impacts to a less than significant level.

• This project should not be visible from South Tufa or Hwy 395 south of the Tioga Pass junction.

• I urge Mono County to make additional efforts to balance the needs of the project with the unique, wild, and beautiful nature of this special place. The current draft project does not include alternatives that mitigate the identified impacts so that a good project can go forward.

• Mono Lake, the Gateway of Yosemite National Park, the

community of Lee Vining, and scenic Mono County deserve a better project design than the one currently proposed.

My husband and I own a cabin in the Wawona area of Yosemite National Park and for several years, my extended family has spent two weeks each summer renting two cabins at the Lake View Lodge in Lee Vining. I am familiar with both the South Entrance to Yosemite and the East (Tioga Pass) entrance. Because of this familiarity, I have a unique view of what has happened in the gateway community of Oakhurst (which is the nearest town to our Wawona cabin, and what I fear will now happen in Lee Vining, which we cherish for its beauty and charm.

Oakhurst used to be a quiet and rustic community which contributed to the ambiance of the Sierra foothills; now it is teeming with motel rooms, chain stores and traffic. No one would choose Oakhurst as a place to spend a vacation; it is a wide spot in the road for overflow visitors to Yosemite.

Lee Vining maintains the high desert atmosphere and serenity which we love, and which leads us to spend our vacation dollars in its hotels, stores, and restaurants. It is quiet and dark at night. The small homes on each side of the main street are funky and attractive, a remnant of a bygone era. If the Tioga Inn project is approved, it will fundamentally change the character of the area. There will be increased lights sweeping over Mono Lake at night and increased traffic which will imperil local wildlife and (since it is set off from the town of Lee Vining), pedestrians.

Thank you for the opportunity to provide comments on the Tioga Inn Project and the Final SEIR. I strongly oppose the proposed project for the reasons outlined below.

I have lived permanently in the Mono Basin for over 20 years and have been an active member of the Mono Basin Regional Planning Advisory Committee for most of that time. Prior to moving to the Mono Basin, I was a frequent annual visitor and so my comments are shaped by that perspective as well.

I have attended all the public meetings related to this project through the years and have supplied both written comments and verbal public testimony throughout the process. At this point, comments submitted by way of this letter will not restate all of those points (they are part of the public record and can be reviewed if desired). Instead, I will focus on what I believe to be the most critical points for you to consider as you make your final decision on this project.

### The Project dismisses the Mono Basin Community Plan

The *Mono Basin Community Plan: Visioning to Action* was finalized in 2012 after a series of facilitated community meetings and discussions that involved all members of the community. The Mono Basin Community Plan "is a community-based planning effort intended to guide future land-use, development, and quality-of-life decisions. The purpose of the plan is to inform decision makers at the community and local government levels, as well as other agencies, businesses and entities operating in the Mono Basin, about the needs and aspirations of the community." This plan currently serves as the Mono Basin Area Plan in the Mono County General Plan Land Use Element and guides all Mono Basin RPAC actions.

The process to develop the Mono Basin Community Plan was comprehensive, inclusive, and arduous. Many meetings and workshops were spent discussing community values, visions,

goals, and challenges and all of these conversations resulted (after long hours of collective detailed editing) in a final product that now shapes every aspect of our community. It is my understanding that any project proposal must conform to the current Mono County General Plan and to any Area Plan, if one exists. In this case it is the Mono Basin Community Plan.

The project, as proposed, conflicts with the Mono Basin Community Plan's applicable goals, policies and actions despite repeated attempts by the public to call out specific problems and inconsistencies. (See attached comment letter dated August 21, 2019 for specifics.)

At the Mono County Planning Commission meeting on April 16, 2020, some of the commissioners felt that the Project "fit" with the Community Plan, and in part used that as rationale for supporting their individual vote to approve the project, simply disregarding the overwhelming community voices to the contrary. These voices come from people who live, work and care for this community. Many of them were involved in the 2012 planning process that developed the Mono Basin Community Plan. They have a strong sense of what fits or doesn't fit with our community.

## Five significant environmental impacts of the proposed project are unacceptable

After years of a planning process and here, at the final stage of project approval, there are still five significant areas of environmental impacts associated with the project that cannot be mitigated or reduced to less-than-significant level.

- 1. Exposure of people and structures to catastrophic mudflows resulting from a volcanic eruption.
- 2. Cumulative impacts to deer movement in the project area.
- 3. Exposure of pedestrians and cyclists to unsafe travel conditions between the project site and Lee Vining.
- 4. Significant unavoidable impacts associated with turning movements from eastbound SR 120 onto northbound US 395.
- 5. Project impacts on scenic and visual resources and on light and glare.

Previous comments that I submitted have provided details on these impacts and why they are unacceptable so I will not go into detail again. What is important at this point, is that after all this time these impacts still exist in the project. The lack of connectivity between the town of Lee Vining and the project area is significant in that no creative solution was developed nor was any future mitigation fund required from the developer to pay for a solution that reduces this impact. Beginning with the project-scoping phase four years ago, the developer has repeatedly rejected trail connectivity mitigation even after repeated community concern and input.

The project visual impacts on iconic and scenic Mono Lake, the Congressionally-designated Mono Basin National Forest Scenic Area, and almost all vantage points from the Mono Basin cannot be ignored. In addition to impacts from the structures, glare from reflective objects

during the day and impacts to the dark, night skies of the vast Mono Basin are unacceptable. No amount of downward-facing lights will eliminate the "glow" from this area.

Any one of these five environmental impacts that cannot be mitigated would be significant. The fact that there are five is reason alone to not approve the Project. The magnitude of the impacts provide the rationale to reject the approach that these adverse impacts are in some way "acceptable" and therefore, I believe justify the Board's action to reject the Project. Furthermore, approving a Statement of Overriding Considerations is *not* justifiable given the lack of benefit compared to the significant impacts that would result from this project.

### The Future of Mono County

I will conclude my comments with this citation from the Mono County General Plan Land Use Element (ii-9) as you proceed to evaluate whether or not this project should be approved and go forward or not:

"Residents express conflicting sentiments about additional growth. The concept of a sustainable, successful economy is supported, but the fear is that communities will need to become too big or 'citified' to achieve this, sacrificing the rural characteristics and healthy natural environment valued by residents. The challenge is to appropriately balance economic development goals with the desired rural community characteristics and protection of the natural, scenic, historical and recreational values of the area. Growth does not necessarily mean becoming bigger; it could also mean improving what already exists within the current development footprint."

I urge you, as our Mono County leaders, to find that this Project is not appropriate for the town of Lee Vining or Mono County, that it did not successfully eliminate adverse impacts, and that other than perhaps personal economic gain for the developer, it does not provide benefits (economic, legal, social, technological, or other) that outweigh serious impacts to our community and to the Mono Basin.

Please support Option 2 and do not approve this project.

### Dear Mr. Draper,

Thank you for the opportunity to provide comments on the draft Subsequent Environmental Impact Report (SEIR) for the Tioga Inn Project. I respectfully submit the following comments in strong opposition to the proposed Tioga Workforce Housing Draft SEIR.

First, I believe it is important that you understand my background and experience as it relates to Mono County, the Mono Basin and Lee Vining. I have been a year-round, permanent resident in Lee Vining for 20 years. Prior to that, I was an annual visitor with my family and friends for more than 30 years. After moving to Lee Vining I immediately became involved with the Mono Basin Regional Planning Advisory Committee (RPAC) and have served on it ever since. My comments that follow are my personal concerns arrived at through my experience in the community and in no way reflect the collective view of the Mono Basin RPAC.

### Compliance with the Mono Basin Community Plan

The *Mono Basin Community Plan: Visioning to Action* was finalized in 2012 after a series of facilitated community meetings and discussions and should be used to guide all aspects of the draft SEIR process. The Mono Basin Community Plan "is a community-based planning effort intended to guide future land-use, development, and quality-of-life decisions. The purpose of the plan is to inform decision makers at the community and local government levels, as well as other agencies, businesses and entities operating in the Mono Basin, about the needs and aspirations of the community." This plan currently serves as the Mono Basin Area Plan in the Mono County General Plan Land Use Element and guides all Mono Basin RPAC actions.

The process to develop the Mono Basin Community Plan was comprehensive, inclusive, and arduous. Many meetings and workshops were spent discussing community values, visions, goals, and challenges and all of these conversations resulted (after long hours of collective detailed editing) in a final product that now shapes every aspect of our community. It is my understanding that any project proposal must conform to the current Mono County General Plan and to any Area Plan, if one exists. In this case it is the Mono Basin Community Plan.

The project, as proposed, is thoroughly in conflict with the Mono Basin Community Plan's applicable goals, policies and actions. The Mono Basin Community Plan was approved in 2012 and is an Area Plan in the Mono County General Plan. CEQA requires that the Draft SEIR be consistent with the Mono Basin Community Plan.

The Draft SEIR (5.5-17) states that the "Mono Basin Community Plan was developed by the Mono Basin RPAC". This is incorrect. The Mono Basin Community Plan was developed by the community members of Lee Vining through an intense, facilitated process that included multiple meetings, surveys, and detailed consensus-based drafting and editing to achieve a final plan that most accurately represents the community of Lee Vining.

The draft SEIR attempted to analyze project impacts as they relate to the Mono Basin Community Plan and, frankly, fell short. Below are the details as compared to section 5.5 of the draft SEIR which provides Mono Basin Community Plan goals and objectives and SEIR responses. My comments are italicized below:

Goal 1: Maintain the spectacular natural values of the Mono Basin and rural, small-town character of communities by managing growth, ensuring high-quality aesthetics, and providing for community development needs to enhance the quality of life for residents.

<u>Objective A</u>: Provide for the orderly growth of Lee Vining in a manner that retains the smalltown character by directing future development to occur in and adjacent to Lee Vining.

<u>SEIR states</u>: The project would be consistent with the objective to pursue orderly development in and around Lee Vining, as well as the policies to prioritize existing built uses over new lands. Water and propane services would be provided (if desired) to supplement existing infrastructure in Lee Vining.

I do not consider tripling the population of Lee Vining orderly growth. Community growth at that rate, all at once, does not allow services such as volunteer fire departments, paramedics, schools and other county supported programs and infrastructure to develop as it would with more gradual incremental growth. The size of the development and the fact that it will dwarf Lee Vining, does not retain Lee Vining's small-town character. The project fails to adequately address connectivity between the project site and the town of Lee Vining, further exacerbating and degrading the quality of life for residents and visitors.

<u>Objective C</u>: Encourage building types and architectural design compatible with the scenic and natural attributes of the Mono Basin.

<u>SEIR states</u>: New uses will incorporate the colors, materials and rustic design elements of the existing Tioga Mart development. The siting of new uses incorporates recommendations of the project biologist as well as visual perspectives gained from the schematic renderings. Green energy will be integral to project infrastructure. The workforce housing will be designed as a residential community located inside a commercial development. All project lighting will conform with dark sky regulations that were enacted after the original Specific Plan was approved.

The color or architectural design will do little to mitigate the fact that the workforce housing has been sited out on a promontory bluff, highly visible from all areas of the Mono Basin. The current range of alternatives does not address nor utilize all possible ways to mitigate the visual impacts of the housing units such as grading below current surface levels, creating berms to shield project structures, or simply moving them to another location on the property perhaps below the moraine. Instead, it appears as though the highest priority of the housing project is to create the best views possible of Mono Lake for future residents presumably to maximize "market rate" rents. I find it ironic and sad that the residents of these units will reap the rewards of iconic and scenic Mono Lake with no visual impacts from their units, while the rest of the community is forever changed with a diminished viewshed. Project lighting conforming to dark night sky regulations will not be enough to mitigate the mere quantity of lights necessary for the project development. The impacts to the Mono Basin dark night skies will be significant from every corner of the Basin, impacting both residents and visitors. Even with downward facing lighting, the glow that will emanate from the project area will be significant and visible from all points in the Mono Basin.

<u>Objective D</u>: Maintain, protect and enhance the natural, historical and recreational attributes of the Mono Basin.

<u>SEIR states</u>: No historic resources have been identified in the Cultural Assessment; however, the project site does have a cultural monument erected by the Bodie Chapter of E. Clampus Vitus that features 'little known and forgotten facts about Mono Lake.' The Kutzedika Indian Tribe of Lee Vining met with Mono County during January 2019 to discuss their history in the Mono Basin and their concerns about the project proposal (see EIR §5.4). Onsite trails will be provided, and the applicant and county have indicated they will jointly seek grant funding for safe trail linkage from the project vicinity to the Lee Vining Community.

Objective D is a foundational pillar of our community – "natural, historical, and recreational attributes of the Mono Basin" and the only way that the project will address and support this outside the project area is through the possibility of a grant to connect the project area with the Lee Vining community. Pedestrian connectivity between Lee Vining and the project is essential and should be a mandatory, required mitigation funded entirely by the proponent. I'm confident that there are other mitigations that could be developed such as a trail system in Lee Vining Canyon that would help to mitigate impacts to wildlife by focusing residents and hotel visitors on a particular route rather than dispersing them throughout the canyon, therefore interfering with natural patterns and behaviors of wildlife.

<u>Objective E</u>: Promote well-planned and functional community uses that retain small-town character and increase quality of life.

<u>SEIR states</u>: The project would increase the housing supply available to local workers, and occupancy would be linked to eligibility criteria. Ample parking would be provided for customer vehicles (standard & oversized), as well as transit vehicles (YARTS & ESTA) and car-pool participants. The project incorporates partnership opportunities including increased airport utilization (through rental car availability). Trails would be provided onsite for walking and bicycles, and efforts will be made to obtain grant funds for development of a walking/biking trail that would safely link the project site to the Lee Vining community. The 1993 project design was developed to optimize public access to the scenic resources and views around the US 395/SR 120 junction, and the newly proposed uses will be largely screened from offsite views.

Again, tripling the size of Lee Vining is not retaining "small-town character".

As mentioned above, the possibility of a grant to connect the project site with Lee Vining should be a mandatory mitigation funded entirely by the proponent.

It is not clear from reading the draft SEIR who the housing would actually be for. In some places it states that it is for the onsite hotel and restaurant employees (but that project has yet to be built and some speculate it might not ever be built). Other places in the document it states it is for seasonal Mammoth Mountain employees, and at public meetings the proponent has said that it would be for anyone working in Mono County. Regardless of the shifting answer, one thing is clear: currently any eligibility criteria is not tied to any clear enforceable measures, either through the County or another oversight entity. Furthermore, The Mono Basin Community Plan specifically calls out requirements for workforce housing which include "establish tenant eligibility criteria, including a time requirement as a local resident and/or local employee, for workforce housing units, and identify the entity that applies, manages, and enforces the criteria". The Mono Basin Community Plan also directs proponents to "promote workforce housing opportunities that connect the community with housing programs." As drafted, the current proposal does not go far enough in prioritizing the local needs of our community.

The newly proposed uses will not be screened from off-site views as discussed throughout this letter. The Mono Basin Community Plan clearly states "recognize the junction of Highways 395 and 120 as an important viewshed for the community and its visitors, and therefore, a project should avoid potential impacts to that viewshed".

<u>Objective F</u>: Provide appropriate public infrastructure and service capability expansion to support development, public safety, and quality of life.

<u>SEIR states</u>: Water, sewer and propane demands of the existing and proposed project will be met onsite, and the applicant will make water and propane service available to customers in Lee Vining. A sizeable share of the demand for electricity will be met through solar panels to be installed on all structures, and a cell tower located on the property supports Wi-Fi connectivity for project site and the region as a whole. The site serves as a staging area during emergencies, and provides space adequate for helicopter landings. All project utility lines will be underground (only the SCE overhead lines will remain).

The Mono Basin Community Plan directs that "future development should coincide with infrastructure and service capability expansion." The project as proposed stands to triple the population of Lee Vining yet there is no discussion or plan on how local community services such as volunteer fire departments, post office capacity, the capacity of our schools, or public parking (to name a few) will be able to accommodate the sudden surge in community population.

Goal 2: Grow a sustainable local economy with diverse job opportunities that offers year-round employment and wages that reflect the cost of living in the area.

Objective A: Plan for a diversified, sustainable economy.

SEIR states: The proposed workforce housing will support continued development of a diversified, sustainable economy in the Mono Basin.

This is a completely insufficient explanation of how the workforce housing will specifically support this particular objective. How will the workforce housing proposal achieve a diversified and sustainable economy for Lee Vining?

Objective B: Enhance and support the existing tourism-related economy.

SEIR states: The project will support community efforts to promote longer stays, provide more visitor accommodations, host YARTS services, provide extend tourism into the shoulder seasons, and explore expanded use of the Lee Vining Airport. The applicant has communicated with USFS regarding the potential availability of housing for Yosemite employees, and has communicated with Mono County regarding the possibility of providing rental cars to airport customers. Restroom facilities on the site are well maintained and open to the public year round.

The Tuolumne River Plan approved in 2014 addressed the Park housing need through a reconfiguration of their existing facilities in Tuolumne Meadows, thus eliminating the need for seasonal Park housing in the Mono Basin.

Objective C: Diversify the existing economic base and employment opportunities to achieve a more sustainable economy.

SEIR states: The project would contribute to employment opportunities, provide a yearround residential market for locally produced goods and foods and an opportunity for expanded water and propane infrastructure. The workforce housing would increase the local recirculation of wages through increased resident purchases in and around Lee Vining. The onsite cellular tower would continue to support Digital 395 broadband access for the site and surrounding environs.

The workforce housing proposal does not constitute "new business developments and entrepreneurial efforts that contribute to a mix of uses and services" but rather includes redundant businesses (hotel and restaurant) that will threaten the stability of existing hotels and restaurants currently operating in Lee Vining.

The project does not "support the revitalization of Main Street" as the Mono Basin Community Plan calls for, as the project is on the outskirts of Lee Vining. And as stated before, currently there isn't a reliable, funded plan for connecting Lee Vining to the project area.

It is questionable whether or not the occupants of the workforce housing would increase purchases of goods and services in Lee Vining as it would depend where the occupants are actually working. It's quite possible that residents might spend at least some of their money on goods purchased outside of Lee Vining, especially if they are working in Mammoth. Goal 3: Build a safe, friendly community where people feel connected, work together to resolve community issues and are involved in community activities and events.

Objective A: Build healthy social connections and interactions that contribute to a sense of community.

SEIR states: Eastern Sierra Unified School District notes that the project would enrich the school community and that developer fees would cover the cost of new facilities for children in the workforce housing area; onsite space will be provided for playgrounds, social meeting areas, day care, and other workforce community programs.

The project does not specifically propose opening a dialog with schools to collaborate relationships. It does not support the provision of higher education and workforce development programs, or cultivate community leadership, nor does it express support for various cultural and ethnic groups in the community.

Objective B: Encourage and support local events and programs that provide community and youth activities, capitalize on the tourist economy, and bring the community together.

SEIR states: The Tioga Mart will continue to host the popular free summer music events program which is open to all and offers diverse music forms.

Many other community opportunities exist under this objective such as outdoor education, youth activities, after school programs, supporting the local library, and working with the Kutzadika Mono Lake Indian Community. It is disappointing to see that the only institutionalized community offering is an already existing program which provides a direct financial benefit to the proponent since attendees dine and drink at the Tioga Inn while enjoying the musical events.

Objective C: Encourage people to volunteer in the community and participate in events.

SEIR states: A community poster board is provided outside of the convenience store.

Again, this is a disappointing and insufficient offering with a project poised to triple the existing population of Lee Vining and whose community functionality is hinged on so many volunteer organizations.

#### **Process**

The draft SEIR was released to the public on June 14, 2019 with a 60-day public comment period. The RPAC was notified by email on June 17, 2019. The general public was noticed in the newspaper on June 22, 2019.

The Mono County Planning Commission held a workshop on June 20, 2019 explaining the project. I attended that workshop and other than Commissioner Lizza, I was the only member of the public from Lee Vining. Given the long history of the project and the changes described during the workshop from the original November 2016 scoping documents to the newly revised draft SEIR, I

was concerned that members of the Lee Vining community might not be aware of the schedule and more importantly the content.

Immediately after the Planning Commission meeting, I requested that Mono County Community Development hold a community workshop to explain the project changes and that meeting was held on July 30, 2019, with the discussion led in large part by the project consultant.

On August 15, 2019 another Lee Vining community meeting was held so the residents of Lee Vining could further discuss the project and associated impacts and concerns. Supervisors Gardner and Kreitz attended this meeting.

I am summarizing the process timeline for a reason. The original deadline for comments was August 13, 2019 (now adjusted to August 21 to satisfy the 60-day legal requirement from the date published in the newspaper). The Tioga Inn Specific Plan and draft SEIR amendments are a significant project for Mono County. Given the size, complexity (teasing apart what's already approved via the 1993 Specific Plan and what is a new project proposal), and potential impacts to the Mono Basin, a clear understanding of the content and process is critical. My concern is that for such a significant project, members of our community (and I include myself) have not had sufficient time to analyze the draft SEIR to the extent that we would like to, even though Mono County has complied with CEQA noticing and comment deadline requirements.

### Specific plans

In general, specific plans set limits on the maximum building or footprint disturbance of a particular site, including the intensity of the development. The 1993 Tioga Inn Specific Plan approved a building footprint with associated impacts for a 120 room hotel, a 5,000 square foot restaurant, and ten housing units. Now the proponent wants to increase that disturbance and impacts with a much larger housing project that would be 100 units with 150 bedrooms, effectively housing up to 300 people.

The environmental impacts resulting from the already-approved 1993 Specific Plan are significant. Adding cumulative impacts from the increase of 10 to 100 housing units must require a revisit of the entire project so that all environmental impacts can be analyzed and evaluated. Much has changed in our community since 1993; most notably the above-mentioned community plan, an increase in wildfire occurrence and intensity, the 1994 State Water Board Decision protecting Mono Lake, and the exponential tourism and recreational use that Mono Lake experiences as a visitor destination.

Specific plans must specify programs and establish regulations that are necessary to finance infrastructure and public works projects. In my review of the draft SEIR I found very little evidence that this requirement had been satisfied. For a project that at a minimum will triple Lee Vining's current population, I found very few examples of the project offsetting in any way impacts to the community infrastructure and functionality. Simple things such as parking in Lee Vining or access to the post office will be forever changed and in orders of magnitude not fully expressed in the draft SEIR.

### Gateway community

Lee Vining is surrounded by public land and it is special land as evidenced by state and federal designations. The Mono Basin National Forest Scenic Area (the first congressionally-designated

Scenic Area in the nation) boundary is across the highway, 1,000 feet from the proposed project boundary. The Mono Lake Tufa State Natural Reserve, a California State Park unit, encompasses the shoreline of Mono Lake, protecting wildlife habitat and unique shoreline features, the tufa. And 12 miles from the project is the eastern entrance to Yosemite National Park.

In past decades, gateway communities have struggled with the challenge of how best to serve the needs of hundreds of thousands of visitors annually with the needs and health of the permanent resident population and the natural landscape that visitors are seemingly craving in larger and larger doses. Many gateway communities have failed to achieve this delicate balance and are now forever changed, and I would argue, have therefore lost their appeal. I don't want Lee Vining to become another over-developed, sterile, commercialized gateway community. Lee Vining and Mono County are unique and therefore require a unique, thoughtful approach to any development project.

Admittedly, preserving this unique character will be a challenge, now and with each planning decision we collectively make. But we can learn from experts in the field such as Edward McMahon, co-author of *Balancing Nature and Commerce in Gateway Communities*. McMahon recommends the following:

- Many gateway communities are overwhelmed by haphazard growth that fails to meet local needs or aspirations and detracts from the integrity of public lands.
- The vast majority of gateway community residents, both newcomers and old timers, feel a strong attachment to the landscape and to the character of their town. They want a healthy economy, but not at the expense of their natural surroundings or community character. (Note: This exact point was made repeatedly throughout the Mono Basin community visioning process. Please review the plan for specific details.)
- Many residents and local officials feel helpless in the face of rapid change. People know what they like about their communities and what they don't like about new development. They just don't know how they can preserve what they love without saying no to jobs and economic development (or in this case, housing).
- Progress does not demand degraded surroundings. A number of gateway communities have implemented successful initiatives to cope with rapid growth and high visitation. Communities are demonstrating that economic prosperity doesn't have to degrade natural surroundings, rob them of their character, or turn them into crowded tourist traps. (*Gateway Communities* by Edward T. McMahon; *Planning Commissioners Journal*; Spring 1999)

### **Conclusion**

Based on the significant insufficiencies in the draft SEIR, the magnitude of the impacts of the project, and the fact that several major impacts (six in total) cannot be mitigated at all, the only alternative I can support is the environmentally superior alternative, no project alternative.

I will conclude my comments with this citation from the Mono County General Plan Land Use Element (ii-9) which should guide decision makers as they evaluate this project going forward:

"Residents express conflicting sentiments about additional growth. The concept of a sustainable, successful economy is supported, but the fear is that communities will need to become too big or

'citified' to achieve this, sacrificing the rural characteristics and healthy natural environment valued by residents. The challenge is to appropriately balance economic development goals with the desired rural community characteristics and protection of the natural, scenic, historical and recreational values of the area. Growth does not necessarily mean becoming bigger; it could also mean improving what already exists within the current development footprint."

RE: Consideration of Tioga Inn Specific Plan Amendment #3 and Final Subsequent Environmental Impact Report (FSEIR)

Dear Members of the Board,

Following are my comments on the proposed Tioga Inn project for consideration at your public hearing tomorrow.

As a member of the Mono County Planning Commission from 1994-2010, I have followed the development of this plan amendment and the public process with great interest. From my experience sitting on the Planning Commission I am familiar with reviewing project documents, having to make tough decisions and being on both sides of the dais – as a member of the public and as a decisionmaker. I support private property rights and believe they must be balanced with community concerns. I also understand and support the need for various types of housing to meet needs in Mono County, both within our community and in greater Mono County.

I submitted scoping comments in 2016 and comments on the Draft SEIR on Aug. 21, 2019. The County responded to my comments in the FSEIR – see

https://monocounty.ca.gov/sites/default/files/fileattachments/planning\_division/page/29999/f seir\_sections\_1\_thru\_5\_2-28-20.pdf, pp. 159-169. I did not provide comments for the Planning Commission consideration of the FSEIR due to conflicts at the time with my work schedule. I will not rehash comments I previously made on the DSEIR, even though many of them have not been adequately addressed, most notably the dated nature of the proposal contained in the original Specific Plan approved in 1993.

Instead, these comments to the Board focus on several fundamental changes I believe can and should be made that will not only tighten up the project's checks and balances but also attempt to somewhat lessen impacts, if not to a level of insignificance then at least in a way that makes more sense from a project-flow standpoint. Though I remain concerned about the scope and scale of the project, these changes would help to alleviate several of my key project concerns.

1. <u>The project should tighten up the grading requirements and link the grading needed to</u> <u>each discrete phase of the project</u>. The FSEIR proposes to allow the project proponent to grade the entire project area before all three phases of the workforce housing project are built. (It is unclear to me the linkage between grading for the housing and grading for the hotel, even though the hotel and the housing are part and parcel of the same project.) This is illogical and unwise.

First, grading for all three phases of the housing project will create long-term and unsightly visual impacts before the second two phases are built; not to mention before the hotel is constructed, which this housing project is purported to service. Given the substantial public concern about visual impacts of the project, why exacerbate the magnitude of visual impacts by allowing grading of undisturbed native habitat immediately? Instead, why not grade on an "as-constructed" basis in order to phase the visual impacts in sync with the progression of the project?

Second, the project may change over time and ultimately may not require the extensive level of grading that is currently being contemplated. And if the project does change it may require a different grading scheme than the one currently proposed for approval. In the many years since this plan was initially approved, the Tioga Inn Specific Plan project has undergone multiple revisions, including previous amendments of the Specific Plan and original EIR and other project revisions that were subject to a Director's Review (e.g., approval of the Mobil Mart/gas pumps and the cell phone tower were done via Director's Review and the environmental impacts of these modifications to the original SP/EIR were never addressed). It is quite possible based on this project's track record that further modifications may be requested, either by the current proponent or a future owner of the development rights. For instance, what if another buyer purchases the development rights to the hotel and wants to make changes to the project footprint, e.g., to build a more modest hotel or a hotel situated in a different location? If the land has already been heavily graded that may make it more difficult for a new owner to adapt a revised project to topography that has been significantly altered and disturbed.

Third, as one with a degree in Botany I consider the grading of the project site to be an irreversible impact. While revegetation is typically done on development projects that require extensive grading (e.g., housing developments, mines) the original habitat is permanently lost, and visual scars often remain forever. An example is found along highway 120 just west of Groveland. A sizeable parcel (40 acres?) was graded for a development long ago; I remember seeing the land being cleared when I went on trips to Yosemite over the years. There were signs advertising the future development, which I believe was to be a shopping center. It was never built. The scar of that weeded parcel remained highly visible for many years; even today as I drive by that parcel looks highly unnatural compared to the surrounding native vegetation; it is basically an abandoned weed patch now covered with trees. And this example of poor land use planning is in a location not directly adjacent to a National Scenic Area that draws tourists from all over the world.

My point is: why allow the entire project to be graded immediately when visual concerns are paramount to many; when the track record of the Tioga Inn Specific Plan has been to make multiple modifications and if the project is fully graded it may foreclose or complicate future development siting options; and finally when, once graded, the original form and function of the landscape can never fully be restored?

<u>Proposed solution</u>: The grading for each housing phase should be tied to the commencement of construction for that phase of the project.

2. <u>Phase 2 housing should not be built upon an application being deemed complete for the hotel building permit; rather, it should be tied demonstrable progress being made on hotel construction</u>.

Because the EIR states that Phases 2 of the housing project is directly tied to hotel construction it makes sense to explicitly link construction of Phase 2 housing to hotel construction. Yet the EIR proposes to allow Phase 2 of the housing project to be built before the hotel, since Phase 2 housing construction can begin upon the hotel application building permit being deemed complete. The hotel – which has created the purported need for the housing project - could end up never being built (e.g., due to financing challenges for the developer or a nationwide economic collapse as we saw in 2008) at the same time additional housing units are being constructed to serve the hotel. I understand the need for housing in Mono County and support the development of workforce housing; however, it does not make sense *from a CEQA standpoint* to allow housing to be built to meet the needs of a hotel that may never be built. (It goes without saying if hotel is not built then Phase 3 housing isn't needed, either.)

Additionally, if the housing is intended to meet general County housing needs rather than the project purpose it seems the project purpose needs to be revised accordingly to make clear that this project is not meant to service the hotel but, rather, to provide general housing for residents of Mono County. If that is the case, it seems the EIR needs to be further revised to address a modified purpose and need.

<u>Proposed solution</u>: Directly link building of Phase 2 housing to hotel construction. The method for how best to do this should be determined by the Board and/or County staff.

3. <u>To alleviate concerns with the visual impacts of second story housing in other phases,</u> <u>the Board should eliminate the second story of housing altogether</u>.

If second story housing is not developed visual impacts would be diminished, even if not being fully mitigated to a less than significant level. Phase 1 allows the development of 30 single story units. Phase 2 allows the development of 40 additional housing units; I am unclear whether any of the Phase 2 housing is two-story. Phase 3, another 30 units, includes multi-story housing.

A balance needs to be achieved between the purpose of the SEIR to house project employees (and/or the desire of the County to help meet its housing requirements) and the significant, unmitigable project impacts of this development. This project simply should not be expected to meet *most or all* the County's or arguably even the proponent's housing needs at the expense

of the environment. Even if second story units are eliminated housing will still be built to help service the project and/or meet the County's housing needs.

<u>Proposed solution</u>: Permit one story housing only. Phase 3 (and Phase 2 if relevant) should be modified to eliminate the second story housing.

4. <u>The Board should require that a County task force be set up immediately to address the critical public safety issue of connectivity to town. The task force should include SCE, Caltrans, County officials, the project proponent, the school and selected community members. A mitigation bank should be established into which the developer should be required to place monies to help fund the developer's fair share of providing safe pedestrian access between the project site and the town of Lee Vining.</u>

According to the staff report of June 29, 2020 both SCE and Caltrans have indicated their willingness to consider supporting safe pedestrian (and bike) access on their lands between the project site and Lee Vining. Safe access is needed *now*, not after the hotel it built. It would be well-used upon completion of phase I construction by children walking or biking to school, project residents visiting the market or post office (or Lee Vining residents visiting the Mobil for a night of music) and, eventually, tourists staying at the hotel.

Construction of pedestrian access between the project site and Lee Vining is feasible given the receptivity of the agencies with jurisdiction. It is critically important mitigation that, if implemented, could serve to greatly reduce the threat of significant adverse impacts of this project on pedestrian safely.

<u>Proposed solution</u>: Agencies, the public and the proponent should meet, identify a potential trail alignment, identify barriers to the trail (e.g., environmental issues) and the means to address them via mitigation, identify cost projections including the need for a CEQA analysis, and a projected timeline for development and completion of the trail. Since this project cannot be accomplished immediately the developer should agree to pay into a mitigation fund – once projected costs are identified – that represents his fair share of trail project costs.

In conclusion, I would like to see the Board develop better "triggers" for appropriate phasing and grading of the project. Because the Specific Plan may change yet again (especially if development rights for the hotel or some of the housing entitlements are sold to a new developer), it makes good sense for the Board to proceed very carefully by not permitting irreversible project impacts to occur. I would like the Board to eliminate the second story of the proposed housing in order to help alleviate visual impacts. Finally, I would like the Board to promptly take the lead in helping to ensure that safe pedestrian access is developed between the project site and Lee Vining and ensuring that part of this cost is borne by the developer.

I first came in 2009 to see and photograph the tufa formations. I have returned (and would love to return again) because of the clear night skies and numerous possibilities to practice nighttime photography that this area offers.

My interest in Mono Lake made me sign up for the newsletters of the Mono Lake Committee. This is how I have learned about the Tioga Inn Project and decided to write you this letter today.

To be brief: I think it is a bad project. Major drawback for me as a tourist - if completed it will add so much light pollution in the area at night. This will destroy the possibility to observe stars at night, which is one of the main tourist attractions of the place. That would be a real shame, because there are not so many places on our planet left where you can do this. For example you will be hard pressed to find a similar place in the European part of Russia or anywhere in Europe at all. Which explains why we (European tourists) take the trouble to come to places like Lee Vining. You are really lucky to have Lee Vining and Mono lake within just a few hours of driving distance from all major CA cities.

Maybe more important is the fact that a lot of Californians seem to love the place and come to the area regularly to enjoy nature that is free from real estate development. We are writing to you to voice our concerned opposition to the proposed Tioga Inn project in Lee Vining.

The project will have a significant, unavoidable, direct, cumulative and adverse impact on scenic resources and visual character. People travel from all over this country and all over the world to see the beauty of the Eastern Sierra and our much beloved clear and dark night skies [and support Mono County's tourism industry] and these impacts are simply intolerable. Degrading the views of the scenic Mono Basin is unacceptable and with no plan in place to fully mitigate all of these impacts, the plan should be denied.

The project will bring significant, adverse, and unavoidable cumulative impacts to the Casa Diablo Mule Deer Herd. The growing scope of the Tioga Inn project will further constrain migrating deer and will likely result in additional deer-vehicle collisions immediately north and south of the intersection of Highway 395 and Highway 120 West. It is long past time that we start valuing and protecting to the greatest degree the other animals that call the Eastern Sierra home. This project poses a threat to both deer and human safety and the plan should be denied.

The project will ultimately make the existing housing shortage problem worse for Mono County be only providing for 2/3 of the forecast future onsite employees [at best]. Also, the project deliberately avoids any guarantees that the housing will be affordable. It is unacceptable that Mono Basin and surrounding communities experience exacerbated seasonal housing shortages and increased rents and the plan should be denied.

We are saddened and frustrated that the county has accepted and would continue to approve a plan that so directly conflicts with the spirit and intent of the Mono Basin Community Plan and it is contrary to most of the plan's values, policies, goals, and objectives. This leads to mistrust of county officials and is no way to build community or strong working relationships in Mono county. This plan should be denied.

As you know, the High Sierra Energy Foundation is a non-profit organization with a mission to promote the culture of energy efficiency and sustainability in the Eastern Sierra. We promote these foundational goals through education and awareness building of the benefits one can achieve by evaluating and implementing technology and best practices to lower the environmental impact of buildings and actions.

As part of that mission, we urge you, or the ultimate developer of the project, to review all options to design and build the most efficient buildings possible, with specific emphasis on electrification and decarbonization and consider a Zero Net Energy (ZNE) or LEED certified building. We often see that a budget is set for a project and little consideration is made to analyze upfront costs versus ongoing reduced operating costs and benefits of efficiency measures and renewable energy generation.

In the 2007-2008 California Strategic Plan, the California Public Utility Commission adopted ZNE goals that all commercial construction in California will be ZNE by 2030. ZNE can be defined as, "The societal value of energy consumed by the building over the course of a typical year is less than or equal to the societal value of the on-site renewable energy generated." This project would be an excellent one to aspire towards ZNE and interim energy and decarbonization reduction targets based on measured-performance due to its intimate connection with nature.

I, Susan Burak, am writing today to document my concerns regarding water supply issues with the proposed Tioga Inn Project. I am a hydrologist with experience in groundwater/surface water interactions.

The two wells that are expected to supply water for the project have limited capacity. Well 1 has a completed depth of 600 feet. Static water levels are 340 feet down from the top of the well casing, leaving a 260-foot column of water in the well. A four-hour pump test at 150 gallons per minute drew the water column down 210 feet, to a depth of 550 feet in a 600 foot well. The drillers log does not provide the depth of the well pump- typically a pump is located well above the bottom of the well. In this case, if the pump was located 25 feet above the bottom of the well, the column of water that would be available for use is only 25 feet.

The second well has similar characteristics and drawdown after a 10-hour pump test was 255 feet. The water level in well 2 after the pump test was close to the bottom of the well. There is no information on recharge rate on both wells. Knowing how much time is required for water levels to return to static levels is key for managing pumping rate as well as simply knowing there is enough water to supply the project. The fact that water levels in both wells fell to close to the bottom of each well requires further study to determine if the wells are capable of providing total annual water demand as well as providing water for irrigation. Assuming the wells will provide irrigation water while the wastewater treatment facility is being built must be include the calculations used to estimate annual and maximum water demand projections.

The total annual water demand for the project is estimated to be about 37 AFY. There is no data on how this number was calculated; estimates of the maximum water demand at build out are also lacking. The capacity of the wastewater treatment system is reported to be 46 AFY, therefore the SEIR should assume a maximum annual demand of 46 AFY.

While treated wastewater is planned for "most" of the outside irrigation, well water will augment wastewater. Outside irrigation is expected to use up to 60,000 gpd. Assuming the outside irrigation season is May through the end of September, approximately 27 AF will be used by outside irrigation. "Most" of this irrigation water will be treated waste water. Details as to the

volume of well water required to irrigate during project construction is essential because the wells may not have the capacity to provide water for the project and outside irrigation without negative effects on Lee Vining Creek.

Longer duration constant rate drawdown tests (12 to 24 hours) coupled with recovery tests are needed to provide short- and long-term drawdown estimates, pump setting and recharge of the pumped well. Information from these tests are necessary to determine pumping limits and to draw informed conclusions on the possible interactions with Lee Vining Creek. The flow values given in the SEIR are optimistic (25 cfs) and do not reflect the range of measured flows of 10 to 25 cfs. A more detailed analysis would be necessary to determine how much, if any, stream depletion occurs from Lee Vining Creek as a result of pumping the project's wells. During the growing season, Lee Vining Creek flows have been recorded as low as 15 cfs, and as low as 10 cfs in winter. Flow measurements are taken below the LADWP diversion dam.

The effect on the creek would be determined by the change in the gradient of the groundwater surface elevation adjacent to the creek. Longer duration pump tests are needed to evaluate the impacts on both the water supply wells and Lee Vining Creek. Until further studies are completed, strict pumping limits need to be included during low flow times of the year. Longer duration pump test information, documenting drawdown and recharge in the two wells and recording the water surface elevation in the creek will provide the information needed to characterize the magnitude of the impact of this project.

Without additional pump tests and a knowledge of the recharge rate, there is a high level of uncertainty regarding the capacity of the wells to supply the project and minimize or eliminate impacts on Lee Vining Creek.

In general, the project would be improved with an overall reduction in size that would make the visual and environmental impacts less obtrusive and aligned with the scenic values of the Mono Basin.

I've spent a lot of time in and around Lee Vining - conducting research in Tioga Pass and for many years leading trips as part of Bird Chautauqua. Mono Lake, Lee Vining and the surrounding basin and mountains are a spectacular place. I'm sympathetic to the desire for economic development for the town and in wanting to enable more people to appreciate and enjoy such a special part of California.

However, a development of this scale is inappropriate for its location and from my read of the environmental documents will likely fall short of its intentions, even exacerbating some of the challenges the town faces in terms of housing. Such a development will likely spoil many of the natural resource values that attract so many visitors, including the dark sky. Also, given the location it will have significant wildlife impacts - such as those to migratory deer herds. Thank you for the opportunity to comment on the Tioga Inn project, which I strongly oppose.

Those in support of the project say it will provide affordable housing to meet the existing need in Lee Vining and Mono County. But it won't.

The document you're voting on today states that the purpose of the project is to provide housing for the employees of the future hotel and restaurant and their families. Therefore, the project will *not* provide housing to meet the existing need. The document states that the type of housing proposed is 97% market rate, which means it will *not* be affordable housing for the workforce or the community.

I have been asked if I think it's a good thing that employers provide housing for their employees. I do. However, this project as proposed will not actually do that.

With 97% of the project housing at market rate, I doubt that the hotel and restaurant workforce will be able to afford to live there, and will look elsewhere for housing, increasing the demand in Lee Vining, June Lake, Bridgeport, and Mammoth and thereby worsening Mono County's housing shortage.

#### Honorable Mono County Supervisors,

Here are the comments I intend to present verbally via Zoom during your meeting today. Below these comments are additional comments, mainly regarding the Planning Commission meeting of April 16 during which I presented comments.

#### June 29 comments:

"My name is Barry McPherson, descendent of a family that came to Mono Basin about 1909. My wife Denise and I inherited the McPherson property surrounding, but not including, Mono Inn. Thank you for this opportunity to comment on the proposed Tioga Inn.

I strongly encourage you to reject the Planning Commission recommendation to approve Tioga Inn in its current design.

I was born in Bridgeport, and raised in a house below Grandmother Venita's Mono Inn. Her son Wally, my Dad, ran a tour boat on Mono Lake from 1938 to '50, and initiated the commercial harvest of brine shrimp.

Grandma Venita, and Dad, stated many times: "We don't want Mono Lake developed to the same extent as Tahoe". They saw Mono Basin as very unique, --- with its saline lake, tufa towers, broad vistas, brine shrimp, and migratory birds. And it lacked a heavily forested shoreline to screen off development. <u>I totally agree</u>.

I think the Tioga Inn plan approved by the Commission would push Lee Vining and the Basin over the edge toward oversized development that detracts from the unique character, beauty, and nature of both.

I also oppose the current plan because I love the people of Lee Vining and the Basin, some of whom I grew up with, and others I've come to know while managing our 96 acres near Mono Inn for conservation, and for renters who work in the area. I have read and heard how most locals strongly object to Tioga Inn as currently designed --- because it will greatly change the character of the town, and their lives, in negative ways.

I was very disappointed when I provided testimony for a second time, and then witnessed the Commission approve the plan at their April 16 hearing. I have rarely seen such a complete rejection of the overwhelming will of local people.

Please vote this down and have the developer and county planners work hard --- with the community ---- to create a smaller and better Tioga Inn development.

I provided written suggestions to this planning process in 2016 and gave verbal comments to the Commission on April 16. I have consistently stated that the Tioga Inn project needs to be downsized to a reasonable development for Lee Vining and the Mono Basin. I have stated that expansion could be considered in later years after assessing the impacts of the initial development on the people of Lee Vining and the rest of the Basin, as well as impacts on the character, beauty, and nature of both.

During the April 16 Commission hearing, I was a bit appalled at some comments from Chair Scott Bush and Commissioner Dan Roberts. Using little jokes to "soften" their intent, they characterized all of us who testified against the project as being mouthpieces of the Mono Lake Committee. They implied the situation was zealous environmentalists versus needed economic development. While I agree with many concerns and suggestions that have come from the Mono Lake Committee, the concerns expressed on April 16 were much broader and from many who had little, if anything, to do with the Mono Lake Committee. Chairman Bush also implied that after nearly 30 years of planning, the Tioga Inn project plan was overdue for moving forward. Well, I think nearly 30 years of inadequate and insensitive planning does not make a project ready for approval. And I think many others who are not part of the Mono Lake Committee agree with me.

Thank you for considering my written comments prior to making a decision in regard to proposed activities for the Tioga Inn Project, Lee Vining, CA. I strongly oppose all developments in the plan at the site. I recognize that you are making a decision about the specific items currently proposed. Although I have attempted to address singular items in the past, I continue to find that ignoring the main issue – the cumulative impact of increase in business, population, and infrastructure beyond the existing conditions – is like tending to a flaming leaf while the forest burns. Thus, my plea today for opposing the project is to prevent the loss of a precious and rare condition, that is, the historic, rustic, Sierra Nevada community and culture of Lee Vining. If there were an Endangered Rural Communities Act, analogous to the Endangered Species Acts, Lee Vining would certainly be designated endangered by the development plans in the current proposals for growth at the Tioga Inn site. Please reach into your hearts and minds to protect this remaining community that we treasure, and vote against the developments at the Tioga Inn.

Below I repeat my comments to the April 14, 2020 Planning Commission meeting on Resolution 20-01. At the time, I was shocked and dismayed by the manner in which the Commission ignored the overwhelmingly opposing statements that were presented then about the Tioga Inn developments. I am confident that by contrast you, our elected representatives, will listen to our comments sincerely, and take them into consideration when you make your decision:

## My comments to the Planning Commission:

My name is Connie Millar. I have owned a home in Mono City since 1993 and, as a Forest Service research scientist, I have worked in Mono Country as part of my federal position since 1987. My comments are given as a private citizen. **I oppose Resolution 20-01.** While recognizing that the Specific Plan Amendment is under discussion today, I'll highlight the most important issue in my mind: that the 1993 EIR is invalid due to significant changes that have occurred over the past 27 years and that were not considered in the original assessment. These changes demand a new project EIR. Examples of changes include:

1) Climate change, including changes in wildfire and smoke, drought, heat events, and annual snowpack and water. Those have had cascading impacts on wildlife diversity, forest health, visitor use, and recreation that relate directly to the Tioga Inn Project. The Mono Basin has endured significant climate change effects that were neither imagined nor evaluated in the 1993 EIR.

2) Sierra Nevada rural communities. Reports of the Congressionally mandated Sierra Nevada Ecosystem Project, published after the 1993 EIR, redefined the role of rural communities in the Sierra Nevada, emphasizing their individual character, key values, and vulnerabilities. The reports described threats to communities from sprawl, influx of urban culture, loss of core areas, and erosion of local culture from developments that would overwhelm the historic

community. The subsequent Mono Basin Community Plan built on the foundations of the pioneering SNEP descriptions for healthy communities. Full impacts to Lee Vining as a signature rural Sierran community were neither understood nor evaluated in the 1993 EIR.

These are only a few examples of changes since 1993 that affect environmental impacts. The piecemeal plans under consideration today ignore these changes. We must conduct a new EIR to address current environmental realities. **For these reasons I oppose Resolution 20-01.**

Supervisors,

I am a life-long Eastern Sierra resident and a Mono Basin resident for the last 3 years. I am also an architect with 15 years of experience including the permit process for various projects around the East Side.

Since this project is about housing, I think I have a good perspective on the subject. I have lived in half a dozen residences of various quality during my 38 years in the Eastern Sierra including an affordable housing unit that I purchased from Mammoth Lakes housing, and later sold, during Supervisor Kreitz's time there. I have also taken part in the design of more than 20 new and renovated single family homes as well as a couple of condo projects. I have seen it all good, bad and ugly.

In the last few month's I have heard the notion that there is no such thing as bad housing, or that any housing is better than no housing. This simply isn't true. There is bad housing and this project is rapidly headed toward that end. It is bad housing because it doesn't cover the entire demand that the hotel and restaurant will create. It is bad housing because its location is too far from the other large demands in the county namely June Mountain and Mammoth Mountain to be useful for off-season use. And Lee Vining, while in need of housing, certainly won't fill all 100 units. It is bad housing because it is separated by a highway and a creek crossing from the community whose services it seeks to use. It is bad housing because, so far it looks more like army barracks than sustainably livable workforce housing. This is bad housing because it's only real purpose is to enable the other half of the project, the hotel and restaurant which are also poorly conceived.

And maybe that is the point. The applicant certainly doesn't want to set the standard any higher than the bare minimum because that is what will ultimately make him the most money. This is not a new situation. It is the game that developers and jurisdictions have played for decades. It therefore falls on the County and the Board of Supervisors to set the standard at a more acceptable level.

Many of you knew my father and the work he did as a planner with the Town of Mammoth Lakes and Mammoth Lakes Housing. I don't know what he would think about this project if he were here today, so I won't speculate. I do wish I could channel him because I'm sure he would have the perfect compromise or at least a sage bit of advice. I do know that when he worked for the town he was constantly disgusted with the way the Town Council never held the developers to account. He always thought they sold out too soon or didn't get everything the community deserved because they were afraid of pushing them too hard and scaring them off.

This is probably where I got my position on the subject. That and my own experience with developers. Every one of our clients is technically a developer and some push the limits of zoning and land use more than others. But it is almost universal that they have the same sentiment, they don't care what they ask of them, they only wish the Town would make up their mind, set a standard and hold everyone to the same standard. I think it speaks to the nature of your relationship to the project before you today. A good developer can work within any reasonable framework. Unfortunately the framework provided by this specific plan gives too much away at the cost of several unmitigated impacts, the destruction of the character of Lee Vining and the promise of continued housing woes for our County.

This property does have great potential for good development, and I certainly don't expect that it should sit empty for all time. I do think that the County, and you as Supervisors, need to make it clear to this developer and by association any developer in our County that we do have expectations and they are more than the bare minimum.

I am a 20 year resident of Mono County, 17 of which I have lived in the Mono Basin. Specifically, I am a home owner and small business owner in Mono City.

I would like to start off by saying, I have the utmost respect for the Mono County Board of Supervisors -- both in terms of how thoughtfully the supervisors make decisions, and also how receptive they are to input from their constituents. In this case, I am baffled as to how a thoughtful decision can be made with so many unknowns in the equation, especially given the magnitude of the of predictable impacts in the equation (visual, community character, vehicular/pedestrian safety, strain on Lee Vining resources, etc.) and duration (kind of forever).

Number one unknown, will the restaurant/hotel complex for which this is housing development is supposed to provide workforce housing ever be built? Twenty-seven years post plan approval, and zero action, if I were betting money, well....

Number two, if the hotel/restaurant complex is in fact built, there are no constraints in the plan ensuring this housing development would be affordable to service industry workers (other than the 3% that would have to be affordable housing...it's the other 97% I am worried about). Market rate in Mono County is out of reach of most of the workforce here.

To be clear, I do not have an "I got mine and screw the rest of you attitude"; I do think workforce housing is an issue worthy of attention. I would love to see all workers in the area have affordable housing. I would hope that all the wonderful kids growing up here would be able to afford to stay on if they so desire -- I love the kids in this community. The local community is exploring affordable housing options that don't forever radically change the character of the community or create such a negative visual impact on this wild undeveloped tourist destination.
