B. Direction to Accelerate Consideration of Policy Change to Allow Residential Use of RVs

Departments: CAO, Community Development

20 minutes

(Robert C. Lawton, CAO) - Mono County Governance Handbook protocol for interactions with County staff states, "Board member referrals that are anticipated to involve significant staff time or other resource commitment and/or are a departure from established county or departmental policy require Board approval prior to staff starting work." Therefore, direction to accelerate a potential change to County regulations which would allow time-limited residential use of recreational vehicles (RVs) in response to a code enforcement case falls under this protocol as it would require significant staff time and is a departure from established policy. Further, if this work is accelerated, it would displace and delay other Community Development Department (CDD) priorities, including work on

the County's transition to a long-haul system for solid waste disposal. Previous Board direction has been given to discuss a broader policy basis for residential use of RVs than just the code enforcement case triggering this urgency, and the policy issues are complex. Staff workflow currently anticipates an initial policy discussion at the Nov. 15 Board meeting, with a solution likely to take longer.

Recommended Action: It is recommended that the Board take up an initial discussion as anticipated in CDD's current workflow on Nov. 15 and follow established enforcement procedures related to the violation.

Fiscal Impact: Delay of the solid waste disposal transition may have unknown potential fiscal impacts.

RE: Support for the Whitebark Institute grant application for the Eastern Sierra Climate and Communities Resilience Project (ESCCRP): Reds Meadow II Implementation

Dear Ms. Avery:

The Mono County Board of Supervisors wishes to express its support for the Whitebark Institute's grant application for the *Eastern Sierra Climate and Communities Resilience Project (ESCCRP)- Reds Meadow II Implementation*, which will build on work initiated with the ESCCRP Phase I Implementation project on the Inyo National Forest and funded by CAL FIRE in 2021. The ESCCRP is a 56,000-acre landscape-scale forest restoration project addressing both climate and community resilience surrounding the Town of Mammoth Lakes. These uncharacteristically overstocked headwater forests are declining in function due to more than a century of anthropogenic influences. The ESCCRP aims to promote resilient landscapes, help create fire-adapted communities, increase public and firefighter safety, and protect the priceless ecosystem services upon which millions of Californians depend.

The Eastern Sierra Nevada is a remote and unique region of California comprised of rugged mountains, high desert, and rural communities. The region is a year-round tourist destination, supporting rural communities via a robust recreation and tourism economy which is largely dependent on healthy forests. The headwater forests of the ESCCRP area provide vital water resources for local communities, the Central Valley, and the City of Los Angeles, and are home to an abundance of terrestrial and aquatic species. Declining forest health, coupled with a rapidly intensifying wildfire trajectory fueled by climate change, underscores the imperative to protect the ecological and economic resources of the region. The **ESCCRP Reds Meadow II Implementation** is an opportunity for Sierra Nevada Conservancy to continue to serve as an active partner in the Eastern Sierra on our continued journey to achieve regional resilience.

The **ESCCRP- Reds Meadow II Implementation** is a continuation of work completed during the ESCCRP Phase I implementation to restore forest health on the Inyo National Forest. The approximate 1,800 acres proposed would provide forest restoration in high wildfire hazard areas with a focus on the Reds Meadow planning area within the ESCCRP, a priority conservation watershed on the Inyo National Forest. Implementation of these acres would not only allow for immediate action towards restoring forest health and reducing the risk of unnaturally large high severity wildfires, but it will continue to prepare us for restoration on the remaining acres of the ESCCRP at the desired pace and scale of the project.

Funding, if awarded by Sierra Nevada Conservancy, would enable the Whitebark Institute to continue implementation of an additional 1,800 acres of Inyo National Forest lands within the ESCCRP, in a highly vulnerable watershed, and continue to build on acres completed during ESCCRP Phase I Implementation.

Proactive management of forests is our only hope to ward off catastrophic loss of these irreplaceable habitats and the multitude of co-benefits that headwater forests provide. We strongly urge Sierra Nevada Conservancy to consider this application as a pivotal opportunity to continue forest health restoration and promote resilience in the Eastern Sierra.

Yosemite National Park Launches Temporary Peak Hours

Reservation System May 20, 2022

System will help manage traffic congestion throughout summer season

Yosemite National Park – Beginning Friday, May 20, Yosemite National Park will implement a temporary peak hours reservation system. Building on lessons learned during the summer reservation systems in 2020 and 2021, the peak hours reservation system is designed to spread visitation out and reduce chronic congestion in the park.

Park visitors will need a reservation to enter the park between 6 a.m. and 4 p.m. seven days a week. Visitors entering the park outside of the peak hours are not required to have a reservation.

“A visit to Yosemite should be about enjoying the beautiful granite-lined landscape, not sitting in gridlock,” said Yosemite National Park Superintendent Cicely Muldoon. “Yosemite visitors deserve a high-quality experience in this magnificent place. Our goal with the peak hours system is to ease overcrowding during the busiest times this summer while still offering access for all.”

The park will benefit from multiple major Great American Outdoors Act (GAOA) and other infrastructure improvement projects in 2022 to repair roads, trails, campgrounds, visitor facilities, and utility systems. This work will involve the closure of several park areas and impact traffic circulation. For example, the Glacier Point Road, Tuolumne Meadows Campground, Crane Flat Campground, and other sites will be closed for extensive repairs throughout 2022.

The peak hours reservation system will be in effect through September 30, 2022, and reservations will be required for all users, including annual and lifetime pass holders. Each reservation is valid for three days. Reservations are available on www.recreation.gov beginning at 8 a.m. on March 23, 2022. Each peak hours reservation is valid for one vehicle and the occupants of that vehicle.

Visitors who enter the park before 6 a.m. or after 4 p.m. will be required to pay the park entrance fee and that pass is valid for three days outside of peak hours. For more detailed information, please visit: go.nps.gov/reserve.

Peak hours reservations are included for all visitors staying overnight in the park. This includes reservations for The Ahwahnee Hotel, Yosemite Valley Lodge, Curry Village, Wawona Hotel, Housekeeping Camp, and NPS-managed campgrounds. Peak Hours reservations are also included for all visitors with wilderness and Half Dome permits and visitors entering the park via YARTS buses and on permitted commercial tours.

“Yosemite’s visitation affects our gateway communities in so many ways,” said Muldoon. “We are grateful for the helping hand our community partners have extended to make this system work better for all.”

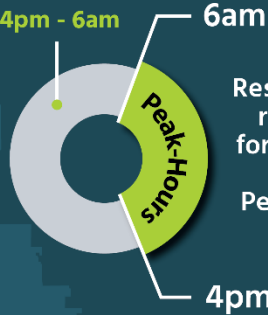

RESOLUTION
OF THE BOARD OF SUPERVISORS OF THE COUNTY OF TUOLUMNE

WHEREAS, access to Yosemite National Park during peak season months is vital to the local & regional economy, and;

WHEREAS, the temporary Yosemite peak season reservation systems put in place the past three consecutive years for emergency reasons have created a barrier to economic recovery in our County by restricting county tourism, and;

WHEREAS, county hospitality occupancy levels remain significantly below pre-pandemic levels, suggesting any impediments to tourism and Yosemite visitation recovery should be removed, and;

WHEREAS, local businesses serving Yosemite visitors have struggled significantly over the past three years due to the effects of the pandemic, staffing shortages, fire & smoke cancellations, skyrocketing insurance costs, inflationary cost increases, and the temporary peak season entry ticket systems, and would benefit from a return to normalcy, and;

WHEREAS, the peak season reservation system provides an unfair competitive advantage to lodging properties within Yosemite, whose guests do not require an entry ticket, thereby unduly impacting hospitality properties within our County, and;

WHEREAS, in summer of 2022 alone, lost peak season tourism in our County is estimated to have resulted in over \$600,000 in lost tax revenue from lodging properties alone, over \$450,000 of which is lost TOT revenue, and;

WHEREAS, wildfire and smoke threats and associated extensive press coverage during peak tourism season represent an additional barrier to tourism, scaring off tourists far into the future, and ticketed entry systems create an additional hurdle to recovering lost tourism associated with fire & smoke threats, and;

WHEREAS, due to the events of the past several years, including Covid, wildfires & smoke impacts, loss of international tourism, changes in domestic travel habits, remote work, inflation, fuel prices, employment constraints and other factors, the peak season demand pressure in Yosemite in 2023 and beyond is highly uncertain and may be significantly lower than pre-pandemic years, and;

WHEREAS, the NPS has this past several years completed significant improvements to Yosemite, including improved traffic flow, roads and parking, which should allow the park to safely accommodate more visitors than in the past, and;

WHEREAS, our County has consistently promoted visitation to county sites throughout the area to help spread tourist visitation and reduce Park impact during peak season, and;

WHEREAS, accounts of improved experiences for Yosemite visitors associated with visitor limits due to entry ticket systems do not conversely recognize the significant frustrations, disappointment and lost experiences of all those unable to visit the Park when they wish;

WHEREAS, the public deserves the right to full enjoyment of public lands as long as it can be achieved safely, and;

NOW THEREFORE, BE IT RESOLVED that the County of Tuolumne Board of Supervisors hereby strongly recommends

- 1) The National Park Service not institute peak season visitation restrictions in 2023 and beyond, and;
- 2) Any long-term pilot system that NPS may consider related to peak season visitation include at minimum 2023 as a baseline setting year with no visitation restrictions in place, and;
- 3) The NPS actively develop marketing campaigns to educate Yosemite visitors about peak visitation issues and options for avoiding crowds and visiting less crowded areas of the park during peak times to lessen the chance that another peak visitation system restricting public access to public lands is needed in the future.

Mono County Governance Handbook protocol for interactions with County staff states, "Board member referrals that are anticipated to involve significant staff time or other resource commitment and/or are a departure from established county or departmental policy require Board approval prior to staff starting work." Therefore, direction to accelerate a potential change to County regulations which would allow time-limited residential use of recreational vehicles (RVs) in response to a code enforcement case falls under this protocol as it would require significant staff time and is a departure from established policy. Further, if this work is accelerated, it would displace and delay other Community Development Department (CDD) priorities, including work on the County's transition to a long-haul system for solid waste disposal. Previous Board direction has been given to discuss a broader policy basis for residential use of RVs than just the code enforcement case triggering this urgency, and the policy issues are complex. Staff workflow currently anticipates an initial policy discussion at the Nov. 15 Board meeting, with a solution likely to take longer.

RECOMMENDED ACTION:

It is recommended that the Board take up an initial discussion as anticipated in CDD's current workflow on Nov. 15 and follow established enforcement procedures related to the violation.

FISCAL IMPACT:

Delay of the solid waste disposal transition may have unknown potential fiscal impacts.
