Mono County Elections Officials send out Residency Confirmations – The Clerk's office has just mailed out 5,875 Residency Confirmation Postcards - one to every active registered voter in Mono County - with instructions to make necessary corrections and to mail the 'no postage necessary' card back to our office. This is required by California Election Code §2220(a) in order to update or confirm voter residency before a primary election. This is very crucial in Mono County as people may change their resident address but not necessarily their mailing address.

NOTE: Your resident address determines your voting precinct. Your voting precinct determines your ballot type. Hence, you vote for the appropriate candidate/race.

With the help of our entire office staff- Shannon Kendall, Sherrie Hale, Debra VandeBrake, Lynda Roberts, and the additional help from Meg Hawkins, we were able to meet the deadline mandated by the Election Code for distribution. "Way to go team!!"

Information Technology

Digital 395 - Progress continues with Digital 395 service turn-up for Mono County and the Town. Both Bridgeport and Mammoth locations are online and fully functional, and the 'point-to-point' connection between the two sites is configured and working properly. We are getting approximately 90mbps downstream speed and 40mbps upstream with very good transfer rates between the sites. The Town's Digital 395 circuit was also turned on last week at the Main Offices and has been configured. The next location priorities are the Mammoth Lakes Police Department, Walker Wellness/Career Services Center, and Bridgeport Clinic facilities, followed by other remote sites where we have County staff. The goal is to eliminate the monthly cost of our Verizon based Internet and Wide Area Network as soon as possible – hopefully by the end of February.



Public Health Hosts State Health visit - On Thursday, January 23rd, the Health Department hosted a site visit from the Emergency Preparedness office of the California Department of Public Health. We were asked to provide documentation and descriptions of about a dozen deliverables that we have completed over the last few years.

Pat McGee, Deb Diaz, Lynda Salcido, and Dr. Johnson participated in the presentation, and our impression is that Mono County Public Health has done an excellent job in accomplishing the objectives set out for us! Several of our products were presented as "best practices", and will likely be used at the statewide conference of all public health emergency preparedness coordinators in Sacramento in June.



We are pleased with the process which allows and encourages our input into the process before final decisions are made. Dr. Johnson is also a member of several advisory committees and workgroups at the state which will weigh in on recommendations to the state, especially including the impact on small counties.

Influenza Update - Influenza activity continues to be widespread in most states including California, with levels above epidemic thresholds in most categories. Hospitals in the Eastern Sierra have not had any

further hospitalizations. Outpatient visits at Sierra Park Clinics were decreased as of the week ending

Saturday Jan 25th, but still above baseline levels.

Influenza activity is expected to continue for the next several months, although the actual peak is not known at this time.

- Type A H1N1 "2009 swine flu" is still the most common type, with young and middle aged persons being most seriously affected.
- California is now reporting 95 deaths in persons under 65 years of age.

Affordable Care Act Update - Mono County Eligibility Workers are working hard to connect Mono County residents with health insurance through expanded Medi-Cal and Covered California. The January caseload for pending and approved applications sits at around 300 as of yesterday. Intensive behind-the-scenes work continues on connecting the existing statewide automated computer systems with the new, Covered California system. Most of the big data arteries are connected, however there's still some precision work to be done to attach all of the many small, but crucially important, data capillaries. County staff participates in *daily* conference calls with the State Department of Health Care Services and Covered California to ensure this happens.

Remember that there are many paths to enroll in Covered California health insurance plans and in expanded Medi-Cal, including in-person enrollment with our County Eligibility Workers, self-enrollment online, and through trained Certified Insurance Agents. According to a recent press release from Covered California, the California Department of Health Care Services (DHCS) announced this week that 500,108 Californians enrolled for health insurance and selected plans through the end of 2013 under the Patient Protection and Affordable Care Act, while 584,000 applicants were determined likely eligible for Medi-Cal coverage. DHCS also transitioned 630,000 individuals into the Medi-Cal program from the state's Low Income Health Program. Of those enrolled so far, 424,936 are eligible for subsidies.

Enrollees in Covered California health insurance plans who paid their first month's premium received health care retroactive to Jan. 1, but the enrollment period continues through March 31, so residents are urged to sign up for coverage in 2014. According to Covered California, about 85 percent of consumers who signed up for a plan received some sort of financial assistance.

Sheriff's Office

Sheriff's Office Update:

- 1. The Sheriff's Office swore in a new Public Safety Officer, Carlos Hernandez, this past Monday. He will be a nice addition to the staff.
- 2. This past Sunday night we had suspect run from our Deputy upon the initiation of a traffic stop. Other deputies responded and the suspect was ultimately taken into custody, using one of our

FLIR devices (which pick up heat signatures). The suspect was wanted for several crimes in the Bishop area.

- 3. K-9 Officer Tara was called out to assist on a traffic stop, and alerted to several areas of the vehicle. Tara ultimately located over \$21,000.00 that was associated with narcotic trafficking. The suspect signed over the currency to our office, which was seized and will be placed into our asset forfeiture account. Tara also just completed her first year with our office and Jennifer Hansen sent out a press release (see below) which made 'photo of the day' by Reno Channel 4 News.
- 4. Several of our deputies assisted a Utah motorist on Tuesday who was stranded on the back side of Mono Lake. Her vehicle was extricated and she was able to continue enjoying Mono County and her journey.
- 5. Friday, January 24th, the Sheriff's Office assisted Mono County Probation with probation checks in the north county area.
- The Orbacom upgrade project is proceeding without any major issues. It is taking longer than anticipated but all the vendors and IT Staff are working well together to get this project completed.

K9 MONET Team member a key to success - The Mono County Narcotics Enforcement Team (MONET) is an inter-agency task force with agents representing the Mono County Sheriff's Office and the Mono County District Attorney's Office. MONET's goal is to eliminate and/or reduce controlled substance trafficking in Mono County by means of investigations that ultimately lead to the identification, apprehension, prosecution, and conviction of controlled substance dealers and offenders. During the past year, MONET has had success in working to combat the narcotics problems faced throughout Mono County. This success has largely been in part due to one particular member of the MONET team: "Tara" the 5-year old Belgian Malinois.

"Tara", the narcotic detection K-9, is trained to detect the odor of narcotics, specifically marijuana,

heroin, cocaine, ecstasy, methamphetamine and their derivatives. She is trained to alert to the presence of narcotic odor. Her alert consists of a noticeable change in behavior with a final response of barking, biting, or scratching at the location of the odor. Her alerts vary depending on the location of the odor. She is trained on odor strength varying from residual narcotic odors to the odor of pounds of narcotics.

Having narcotics detection K-9, provides MONET and local law enforcement with an extra tool to help aid in the battle against the narcotics problems faced throughout Mono County. "Tara" has been instrumental in helping locate well-hidden narcotics, in both vehicles and buildings (such as homes), that her human counterpart would miss by just conducting a physical search. In Mono County, especially along the Hwy 395 corridor, more and more drug dealers and traffickers are bringing narcotics into and through our local communities. "Tara" helps find hidden narcotics in cars and other places that most people wouldn't even think would be a hiding place for narcotics. With her keen detection skills, she can assist local law enforcement in conducting interdictory traffic stops on narcotics dealers and traffickers and hopefully recover the narcotics before they even enter our communities.

Over the past year, "Tara" has conducted forty nine (49) successful vehicle searches; twelve (12) successful building search warrant recoveries; and twelve (12) successful school "sniff" searches. She has successfully recovered over 133 ounces of narcotics off the streets and out of the communities of Mono County.

The Mono County Narcotics Enforcement Team (MONET), and the Mono County Sheriff's Office, is fortunate to have "Tara" as a member of our team. As she celebrates her one-year anniversary, we look forward to her continued participation, dedication, and success in narcotics detection and recovery.
