

# **Behavioral Health**

Moral Recognition Therapy (MRT) training - Three members of the Behavioral Health Department—Salvador Montanez, Richard Bonneau and Debra Stewart—joined with members of Mono County Probation to attend a three day Moral Recognition Therapy (MRT) training. MRT is a widely recognized evidence based program to address issues and "problem thinking" by those who are in the criminal justice system. This program can cut recidivism by 1/3 for those who have been or are currently in custody (jail). Having BH staff trained in MRT allows us to provide structured service to those who are involved with the Mono County justice system and work alongside the Sheriff, County Jail, and Probation departments.

On a similar note, Robin Roberts attended a conference in Sacramento put on by the California Institute for Mental Health called: "And Justice For All." This conference had in attendance Judges, BH specialists, Probation officers, and other specialty service providers who work with the mentally ill and substance dependent who are involved with the court system to provide seamless services in an effort to keep those with a severe mental health diagnosis out of the criminal justice system when at all possible. Given the collaborative work within our great county of Mono, this was an opportunity to see how much we are already tending to and what we might want to pursue as we move these programs along.

## **Community Development**

**June Lake CAC** – A special meeting of the June Lake CAC was held Wednesday to continue discussion on regional transportation plan policies moderated by Courtney Weiche and Gerry Le Francois. Thanks to the CAC for putting time and energy into this important planning effort.

**Biomass for heat** – A biomass utilization feasibility study concluded with a presentation at Thursday's Town/County Liaison meeting. Biomass (woody waste) for thermal heat only systems are the most viable, providing a return on investment in 2 to 12 years. The report provides extensive technical information that would help any interested party. Contact Wendy Sugimura if interested.

**Alternative Transportation Program (ATP)** – At Tuesday's meeting the Mono Supervisors approved project concepts to be further developed into ATP grant applications. The complete streets/safe routes to school project focuses on continuing to implement the Bridgeport Main Street project and also touches several other communities. The recreational trails project focuses on June Lake's down canyon trail from Gull Lake to Double Eagle Resort.

**Bridgeport Valley RPAC** – The RPAC further refined the scope of the Bridgeport Main Street project noted above. A cooperative effort by RPAC members, County Service Area (CSA) #5, and Wendy Sugimura has made progress toward beautification and landscaping of Main Street, including hanging flower baskets and design of a banner system across US 395.


