HOME ENERGY EFFICIENCY/PACE WORKSHOP – On FRIDAY, AUGUST 29, 2014 from 2:00 – 5:00 PM at the MINARET VILLAGE MALL, SUITE Z (437 OLD MAMMOTH ROAD, MAMMOTH LAKES) anyone interested in learning more about energy efficient, cost saving projects for your property and financing options available for these types of projects should come to the Workshop being hosted.

Thanks to Board action earlier this year, the PACE (Property Assessed Clean Energy) PACE enables both residential and non-residential property owners to undertake energy-saving upgrades on their buildings with the costs of these upgrades being distributed in

payments on their property tax bill. The advantage is that no up-front

money is needed for these upgrades to be done, unlike traditionally

funded projects that require all project money on the front end of a job.



Among the many projects eligible for PACE include, but are not limited to: Solar PV systems; geothermal (ground source) space and water conditioning systems; energy- efficient windows; roofing systems; insulation upgrades; and energy-efficient HVAC and water heating systems.

Community Development

Local Transportation Commission – After a public hearing at its Monday meeting, the LTC followed the recommendation of Gerry Le Francois to change the adoption cycle of the Regional Transportation Plan from five years to four, which allows the Housing Element update deadlines to be shifted from five to eight years. This change saves significant staff time and potential costs to the County General Fund. Megan Mahaffey reported increased reserves in the Local Transportation Fund, and John Helm provided

a thorough review of Eastern Sierra Transit Authority's operating statistics. Ryan Dermody, Peter Bernasconi & Garrett Higerd presented status of road improvement projects throughout the region.

Mono Basin RPAC – At Wednesday's meeting, Supervisor Alpers reported on efforts with Caltrans to improve conditions near the Old Marina on US 395 in response to a recent motorcycle fatality, provided an update on Conway Ranch issues, & distributed the County's legislative platform. The RPAC focused its meeting on fire issues with a presentation by FPD Chief Tom Strazdins on a new firehouse location & workshop with Sue Farley and Sarah Tomsky of Inyo National Forest on fuels reduction and wildfire defensible space. Courtney Weiche presented a draft report on Mono-Yosemite Trails project.

Planning Commission – At its Thursday meeting, the Commission approved a final subdivision map in Chalfant Valley after extensive work by Garrett Higerd & Walt Lehmann, as well as the first Expanded Home Occupation submittal for a firewood business in Bridgeport. Gerry Le Francois, Brent Calloway, & Courtney Weiche reviewed a variety of proposed amendments to development standards, including mobile food vendors.
