Affordable Care Act Open Enrollment 2015 - Affordable Care Act open enrollment for 2015 starts on November 15th, 2014 and continues until February 15th, 2015. Covered California announced the launch of its community outreach campaign for 2015, including \$46 million in new statewide advertising and \$14.6 million in new community outreach grant funding. The new series of ads, which feature real

Californians who have health coverage as a result of the Affordable Care Act, will begin rolling out this week in markets statewide. The ads can be downloaded at:

Covered California is offering new family dental plans to consumers who enroll in health insurance coverage in 2015. Additionally, all individual health insurance plans sold through the Covered California exchange will include pediatric dental benefits for members younger than 19.

Child Protection Bill Heads to President - The US Senate adopted by voice vote the *Preventing Sex Trafficking and Strengthening Families Act* (HR 4980). Adopted by the House in July, the measure now goes to President Obama who will sign it into law. Both houses have recessed and will return on November 12.

Policy changes affecting child welfare agencies include provisions requiring states to include a "reasonable and prudent parent standard" to enable foster youth to participate more readily in extracurricular, cultural and social activities with their peers. The measure also eliminates Another Planned Permanent Living Arrangement (APPLA) as a permanency goal for children under the age of 16. It will also enable youth ages 14 and older to enlist the assistance of two other individuals to be part of their case planning team.

Effective one year after enactment, the bill will require child welfare agencies to provide youth exiting care who were not adopted or returning to live with family to have a birth certificate, a Social Security card, health insurance information, medical records and a driver's license or state-issued ID.

The adoption assistance program was amended to include, for the first time, incentive awards of \$4,000 for subsidized guardianship placements. It also ensures that a child placed with a guardian could continue to be cared for by a successor guardian if a relative guardian dies or is incapacitated.

The legislation also requires state plans for foster care and adoption assistance to include policies and procedures for identifying, screening, and determining appropriate services for children who are believed to be victims of sex trafficking, or at risk of being such victims. Sex trafficking data would be included in the adoption and foster care analysis and reporting system (AFCARS).

Finally, the bill contains child support provisions making it easier to obtain and enforce orders across international boundaries and requires the federal Office of Child Support Enforcement to engage stakeholders in identifying best practices and other efficiencies in the program.

Wild iris to hold Domestic Violence Awareness and prevention Seminar – Thank you to Susi Bains and Kathy Peterson for sharing this vital upcoming event information. The flier is attached to the Board Update and this issue needs our focus as far too often we hear about violence in our communities.

"Good Afternoon!

As most of you know, domestic violence has been at the forefront of national conversations this past week. It is important to recognize that all of the public conversation and media attention reflect the years of hard work by all domestic violence agencies, including Wild Iris. Good or bad, the media attention has provided Wild Iris a unique opportunity to lead a public conversation and help to educate the community about domestic violence.

In October, we will be hosting a free 2-hour "DV 101" educational seminar. The seminar is designed to be an informational introduction to the dynamics of domestic violence, and will cover a number of topics including, the Cycle of Violence, Common Myths about Domestic Violence, the Effect of Domestic Violence on Children, Red Flags of an Abusive Relationship, a discussion on the common question, "Why Doesn't She Just Leave?," a review of national and local statistics and much more. Most importantly, we hope that it will generate more conversation, and a better understanding that domestic violence is not a "private matter."

Classes are free of charge, and will be held on Tuesday October 7, in Mammoth Lakes from 3:00 pm –5:00 pm, and Thursday October 9, n Bishop, from 2:30 pm-4:30pm. Light refreshments will be served. For more information and
