SUMMARY - The State Water Resources Control Board (State Water Board) is exploring a range of options to enhance environmental benefits from grazing, protect beneficial uses of surface and groundwater, and address water quality impacts potentially related to livestock grazing in California. This Grazing Regulatory Action Project (GRAP) aims to facilitate efficiency and statewide consistency in developing and implementing strategies to meet these goals, while at the same time accounting for regional differences in hydrology, topography, climate and land use. The GRAP process will consider a wide range of alternatives to ensure that grazing has minimal negative impacts on water quality. A cornerstone of the GRAP will be thoughtful consideration of the costs of compliance to the regulated grazing community. The participation of interested stakeholders throughout the development of GRAP is necessary to its success. As an initial step, the Water Boards engaged stakeholder groups in Focus Listening Sessions (FLS) to solicit comments early in this process, before beginning to develop GRAP (No new regulatory approach has been developed.) The FLSs were the first of many opportunities for stakeholder participation. The purpose of the Regional Stakeholder Meetings is to share with stakeholders the comments from the FLSs and gather thoughts, suggestions or other feedback from the community on the FLSs comments and on GRAP.

"The Voice of California Counties is loud and strong in Sacramento and Washington, D.C. But our voice is only as strong as those who participate. Our Association is successful through the participation of you, our members. CSAC needs to reflect the diversity of California, our counties and our membership. That can only happen through participation.

There are several ways you can be involved in CSAC, as outlined below. Participation is <u>not</u> limited to your county's representative on the CSAC Board of Directors; any county supervisor can participate in, or just follow, a CSAC policy committee. These committees meet a few times each year in person or via conference call. The actual number of meetings for each committee depends on the complexity and importance of the issues counties are facing in that particular policy area.

CSAC Policy Committee Meetings

CSAC has five policy committees that analyze and recommend positions to the Association's Executive Committee and Board of Directors that are consistent with the established County Platform. These committees are:

Administration of Justice -- Responsible for a broad array of justice-related issues that includes juvenile justice; probation; courts; local law enforcement; adult and juvenile detention; public records, privacy and open meetings; grand juries; and all county functions connected to the civil and criminal justice systems. The committee has primary responsibility for the development of policies relating to the administration and financing of the various county programs under its purview.

Agriculture, Environment & Natural Resources -- Responsible for developing and reviewing policy on environmental and resource issues that affect county operations and local economies. This wide range of issues includes: agriculture, air quality, water, forestry, mining, endangered species, disasters, energy, parks and recreation, public lands, coastal resources, fish and game, regulatory streamlining, solid waste and hazardous waste.

Government Finance & Operations -- Responsible for recommending policy in all matters relating to finance, general government operations and employee relations. Under that broad umbrella, the committee deals with such issues as taxation, redevelopment, debt financing, retirement systems, workers' compensation and mandates.

Health & Human Services -- The Health and Human Services Committee has responsibility for the development of policies and proposals relating to: aging and long term care, alcohol and drug programs, mental health, the Medically Indigent Services Program, the California Work Opportunity and Responsibility to Kids (Cal Works) program, foster care, child welfare services, adult protective services, the In-Home Supportive Services (IHSS) program, the General Assistance program and the homeless.

Housing, Land Use & Transportation -- Reviews state budget items, ballot resolutions, and state/federal legislative proposals in these three important interrelated areas. Major areas of policy development and review include, transportation/infrastructure planning and funding, public works contract regional government decision-making proposals, housing policies, airport land use commissions, authority of state agencies.

Create Your Own Wrap Bracelet Class offered through County Service Area One: Instructor: Kim McCarthy has provided the following info on a great class being offered by CSA 1. In addition, attached to the Board Update is the CSA's schedule. You will learn to create your own stone wrap bracelet using leather or suede, beads and a button to create a one to 3 wrap bracelet.

Supplies needed: One button with two holes or a loop to tie leather or suede onto 56" of material used, and enough 4mm beads (or up to 6 mm for a larger bracelet) for as many wraps as you like, a needle and thread. The thread can be colored or not, but must be thin enough to go through your beads 3 times.

You can find all the supplies online: Stone beads: Jasper, amethyst, lapis, aquamarine...You can also use Czech crystal beads. Round beads work the best, do not use oval it distorts the shape. www.firemountaingems.com

Community Development

LTC: At Monday's meeting, *Megan Mahaffey* and *Leslie Chapman* were commended on the annual audit, *Garrett Higerd* received Commission support for an early allocation of funds for the Convict Lake Road Rehabilitation, and *Gerry Le François* provided an update on the Regional Transportation Plan. Caltrans staff reviewed processes for imposing SR 108 truck restrictions and discussed US 6 Chalfant

intersection process for speed reduction and improvements. In collaboration with Caltrans, **Wendy Sugimura** provided a thorough and well-received report on Bridgeport Main Street performance measures, with the Commission concluding the project appears to be meeting planning goals and working well, noting that fewer accidents have occurred since the project.

Eastern Sierra Recreation Collaborative: Analyst *Brent Calloway* attended Wednesday's ESRC meeting in Bishop where the public process for drafting a recreation alternative for Inyo Forest staff consideration during the upcoming Forest Plan Update was concluded. The draft alternative will be reviewed at upcoming meetings of the Collaborative Planning Team and the Board of Supervisors.

Bridgeport RPAC: Items discussed Thursday with staff *Wendy Sugimura* included the Marine Corps' Communication Tower project, combined-use roads (e.g., allowing OHV use on certain segments of County roads), efforts to upgrade broadband service by accessing D395, and Main Street design, including a banner/arch across the highway and pedestrian-scale lights.

Sage-Grouse: Mono County is hosting the website for the upcoming Bi-State Pinyon-Juniper Expansion Forum in Minden, NV on February 25-26. *Wendy Sugimura* and *Brent Calloway* have been participating in Local Area Working Group discussions to develop and plan this event. Please check out:

Winter Recreation on the Mammoth and Mono Lake Ranger Districts Update - The Inyo National Forest provides the following information to help visitors pursue winter recreation activities on their national forests safely and responsibly.

Maps: The Town of Mammoth Lakes and the Inyo National Forest have produced a new and free *Eastern Sierra Winter Recreation Map*. Pick up your copy at the Mammoth Lakes Welcome Center, obtain it online or download to your mobile device using the *Avenza* map app (www.pdf-maps.com). A waterproof version of the map can be purchased at the Mammoth Lakes Welcome Center.



Know Before You Go: Winter recreationists must plan their adventure considering the current conditions, the weather forecast, the terrain and geography that will be traveled, and the equipment needs of their party. Even when visiting one of the maintained ski resorts, planning ahead and knowing what to expect will make your winter visit safer much more enjoyable.

Anyone who may be traveling in potential avalanche terrain is encouraged to seek education and training resources; travel with a shovel, beacon, and probe; and have the knowledge required to use these tools. Visit the Eastern Sierra Avalanche Center website for the most recent information on snowpack and conditions www.esavalanche.org.

Play with Your Pet Responsibly: Forest regulations require that all dogs travel on a leash in all developed recreation sites, including ALL groomed trails. Within the Town of Mammoth Lakes, all dogs must be on a leash. Dogs are prohibited on groomed trails in the Mammoth Lakes Basin and are required to be on leash if traveling through the Lakes Basin off groomed trails. Leaving pet waste behind on a groomed trail or in a developed recreation area is littering. Please pick up after your dog and throw it away in the trash. By doing so, you'll help improve water quality and make everyone else's recreation experience more enjoyable.

Nordic Opportunities: Visitors can pursue Nordic recreation in several locations. The Shady Rest Nordic Trails are open, but grooming will not resume until there is additional snowfall. All Nordic users should access the trail system by parking at the Mammoth Lakes Welcome Center and using the trail portal in the Welcome Center Plaza. The Forest Service asks that Nordic users refrain from parking at Shady Rest Park; the park is a primary snowmobile staging area and parking is limited.

At this time, the Obsidian Dome trails do not have enough snow to allow for grooming, but are open and in use by skiers and snowshoers. Grooming will begin after the next significant snowfall. The *Miracle Mile* from Mammoth Inn to Minaret Vista is open and groomed. Parking at the Main Lodge is limited and visitors are encouraged to ride the bus from town.

Tamarack Cross Country Ski Center is open and offering rentals, lessons, and tours to its patrons. All users of the groomed trail system at Tamarack must possess of a valid ski pass. To access the Mammoth Lakes Basin without a pass, users must travel on the un-groomed roads and trails on the forest.

Snowmobiling: The Inyo National Forest is waiting for additional snow accumulations to begin grooming the California Department of Parks and Recreation funded snowmobile trail system. With a shallow, low density snowpack, snowmobilers should use caution and refrain from traveling in areas where snow depths are minimal or vegetation or soil may be damaged. Snowmobile users are responsible for knowing all regulations and understanding closure area boundaries. The Eastern Sierra Recreation Map is a helpful tool and all snowmobilers are encouraged to obtain and read a copy in advance of their snowmobile outing.

Snowplay and other Winter Activities: The only designated snowplay area on the Inyo National Forest is Woolly's Tube Park on Hwy 203 above the North Village en route to Main Lodge. More information can be obtained at www.mammothmountain.com. There are several areas on the national forest where visitors find it convenient and fun to play in the snow, although these sites are not maintained for these activities. Additional information is available at the Mammoth Lakes Welcome Center and at www.mammothtrails.org.

Snow bikes or "fat tire bicycles" and all vehicles with wheels are prohibited from using groomed trails. Those wanting to ride bicycles on the snow may do so on any trail or road that is not maintained for Nordic skiing or snowmobiles and where bicycle riding is not otherwise prohibited. The Mammoth Lakes Welcome Center is an excellent resource for winter recreation information, maps, and guidebooks. The center is open daily from 8 am to 5 pm and can be reached at 760-924-5500. Reconstruction of Rock Creek Road Continues in 2015 Plan for Delays and Parking Restrictions - Major reconstruction on the Rock Creek Road will continue in the summer of 2015. Work on this project began last year.

Mono County requested the funding and the work is being completed on Mono County roads. The Federal Highway Administration (FHWA) has contracted and will oversee the project that will improve the road, widen it, and provide a bicycle lane along a nine-mile stretch between the Rock Creek Pack Station and Crowley Lake Drive.

The Rock Creek Road provides access to wilderness trailheads for the Little Lakes Valley, Mono Pass, and others. The area is noted for its exceptional scenery. Several campgrounds and resorts with cabins along the road are part of the recreational attraction as is fishing and horseback riding. The road itself is used by cyclists because of its challenge and its beauty.

Weather dependent, the work is anticipated to start the end of April. This year, re-building of bridges is planned. Additionally, the reconstruction will continue along the lower part of the project (from the Rock Creek Pack Station to the lower end of the construction near Tom's Place). The project will be completed with the final paving along the length of the construction area.

While the road will remain open to traffic throughout the project, visitors may experience delays of up to 30 minutes. In addition, there will be one week when there will four-hour delays twice per day while they are working on the bridges. This is anticipated to occur sometime in May. Longer closures will be planned approximately three weeks in advance so that recreationalists can plan their visit. Parking will be extremely limited within the construction zone, including trailhead parking areas for the Hilton Lake trailhead. Please carpool if possible. When roadside parking, ensure that your vehicle is entirely off pavement.

Construction will be suspended for Memorial Day weekend, the Independence Day holiday, and Labor Day weekend in order to minimize delays.

Public Health

Happy New Year from EMS. The last year definitely went out with a bang response wise. The Paramedics and EMTs responded to 21 calls on Boxing Day (Dec 26) alone, which makes for a very busy system. Mammoth Mountain has had a definite impact upon the emergency response system since their opening last year, with our agency having 312 calls that have been mountain related since November 9, 2014.

Year-end stats for the agency are in, with Mono County EMS responding to a total of 1,685 calls requesting emergency medical service in 2014. Our agency also responded with local fire departments to render assistance a total of 187 times.

EMS also started to expand several services last year. We are now an American Heart Association Training Site, and are able to handle all necessary documentation and card issuance locally. We trained close to 200 county residents and professionals in the first six months of the program, and look forward to significantly broadening this service throughout the entire county in 2015. Our plans are to expand our instructor base further, which was increased to 8 in 2014. We will also be bringing Advanced Cardiac Life Support and Pediatric Advanced Life Support instruction in house this year, which are two classes necessary to help Paramedics retain and advance their knowledge and skills in these areas.

The agency will also be making a presentation to the Board in early 2015 explaining our development

and strategy of an AED program for the county. This program has received solid support from the Town of Mammoth Lakes, who has placed 8 AEDs in service as of this date.

We look forward to serving the residents and visitors of the county in 2015, and bringing training and education to the many professionals that call Mono County home. Have a Great Year!

Open Enrollment Continues through February 15, 2015 - Open Enrollment is the ONE TIME during the year when most Californians who need insurance cannot be denied by a health plan and when millions can get subsidized health insurance for the upcoming year. (Individuals who have limited income may enroll in Medi-Cal year-round.)

The new <u>Covered California website</u> offers interactive shopping tools that allow individuals to pick a plan that is right for them. Consumers can shop and compare their options based on their age, where they live, their household income and number of people in their household. These factors determine their premium and amount of any subsidy they may receive.

Is there a penalty if I don't have insurance?

You will have to pay a penalty when you file your taxes if you don't have health insurance or an exemption. In 2015, the penalty will be 2 percent of your yearly household income or \$325 per adult (and \$162.50 per child under 18), whichever is higher.
