Community Development

Collaborative Planning Team – At Thursday's quarterly meeting, **Supervisor Alpers** presented a historical overview of the CPT and its formation process in the 1990s, including a motivational pep talk for current team members.




In **Chairman Fesko's** absence, **Supervisor Corless** presided at the meeting, which included analyst **Wendy Sugimura** providing a coordinated multiagency report on sage grouse preservation initiatives. Deanna Dulen presented an update on Devils Postpile General Management Plan; Doug Power reported on Mountain Warfare Training Center's communication infrastructure upgrade project; Justin Fuller discussed Cal Fire's efforts to help area residents create defensible space around homes; and John Wentworth and Danna Stroud described the Eastern Sierra Recreation Collaborative group's recreation strategy for consideration during the Inyo Forest Plan update.

IRWMP – The Inyo-Mono Integrated Regional Water Management group met Wednesday for its regular meeting. A variety of administrative and local water topics were reviewed, including a preview of a comprehensive project database and the looming fourth year of severe drought. Much of the discussion focused on the group's uncertain future and need to secure sustainable funding for administrative operations. Thanks to analyst **Brent Calloway** for representing Mono County at the meeting.

Sage Grouse – Mono County is hosting the website for the upcoming Bi-State Pinyon-Juniper Expansion Forum on Feb. 25-26 at Minden, NV. Analysts **Wendy Sugimura** and **Brent Calloway** have been participating in Local Area Working Group discussions to develop and plan this event. Crowley Skate Park – On Thursday, County Service Area #1 met with County staff to review site plan alternatives for a proposed skate park on the Crowley Lake Community Center parcel. Public Works' Vianey White facilitated the meeting with CSA#1, Supervisor Stump, Community Development's Courtney Weiche, Triad/Holmes Engineering, a representative of the Crowley Lake library, and County Service Area #1 in the funding.



The process included wetland studies and a master site plan reflecting existing facilities, such as the new community

garden, the proposed skate park and contemplated future projects, such as a library. The preferred alternative will be incorporated into a Community Center Use Permit update and supporting environmental document, as previously authorized by the Board of Supervisors. Project consideration by the Planning Commission and County's Project Review Committee is expected this spring.

+ The California Competes Tax Credit is an income tax credit available to businesses that want to come to California or stay and grow in California – especially Mono County! A total of \$151.1 million in tax credits is available for the 14-15 fiscal year. One more round (out of three) of applications will be accepted for the remaining \$31.1 million, plus any unallocated amounts from the previous two application periods. Applications are due between March 9th and April 6th, 2015. Each of the next two fiscal years (15-16, 17-18) will have \$200 million available in tax credits. 

Public Health

E-Cigarettes growing issue of concern for efforts to reduce tobacco related illness --For over 20 years, the State of California has led the nation in anti-tobacco efforts, but the emergence of electronic cigarettes (e-Cigarette) may undo decades of public health efforts to reduce tobacco use in California. Thankfully, many Mono County stores have resisted the urge to contribute to this e-cigarette phenomena.

In a September, 2014, the Mono County Health Department surveyed 19 markets in unincorporated Mono County. 17 (89%) sold tobacco, and only 3 stores sold e-cigarettes. In Mammoth Lakes, 9 out of 12 stores sold tobacco and 4 sold e-cigarettes. However, recent trends are troubling: The percent of stores selling electronic cigarettes rose from 21% to 39%, an increase of 18% over the past year. The percent of stores selling flavored tobacco products also increased from 48% to 58%.

In all stores, e-cigarettes were the least sold of tobacco-related products. "I looked into electronic cigarettes; it is an expensive endeavor to get in to," stated a Mammoth store owner. Another reported, "Kids have come in asking for 'vapes' [E-cigarettes]."

Flavors offered make e-cigarettes attractive to kids. A University of California San Diego study showed there were 288 e-cigarette brands available online in 2012. By January 2014, there were 466 brands

with 7764 unique flavors, such as bubble gum, Captain Crunch, gummy bear and cotton candy. The top e-cigarette brands are owned by tobacco companies. Their products are promoted through TV ads and other media popular with young people.

While some e-cigarette manufacturers claim e-cigarettes emit a "harmless water vapor," e-cigarettes emit small particles that can hurt the lungs of the user and those nearby. Essentially, they are an electronic delivery system for nicotine – a ticket to nicotine addiction and death. California experienced a five-fold increase in the number of calls to poison control centers involving e-cigarette liquid exposures in children aged five and under between 2012 and 2013. At this point, e-cigarette products are completely unregulated, causing a considerable variation in the product and its liquid; many of the products are made in China.

Local regulation does not deal with the product, but deals with access and exposure. A California state law prohibits sales to minors. A 2014 Mammoth Lakes ordinance includes electronic cigarettes in the Town 'No Smoking' policy. Other businesses, such as Mammoth Mountain and Mammoth Hospital, Mammoth Lakes Housing and IMACA low income housing also include electronic cigarettes in their smoke free policies. A bill just introduced into the California legislature would add e-cigarettes to the list of tobacco products regulated in the state, which already forbids smoking in workplaces, restaurants, bars and other places. It would also ramp up penalties for selling e-cigarettes, which come in such flavors as bubble gum and chocolate, to minors. California would be the fourth U.S. state to treat them like regular cigarettes, and the 23rd to regulate e-cigarettes in some way. In California, the most populous U.S. state, 122 cities and counties have banned the use of e-cigarettes in certain public places.



E-cigarette proponents claim they help people quit regular

cigarettes. However, research shows that smokers begin to use both regular cigarettes and e-cigarettes. If e-cigarettes are really meant to help people stop smoking, why are they being marketed to our kids who are not smoking – yet?

To quit with the help of medication, the California Department of Public Health recommends that existing over-the-county nicotine replacement products be used. Their Smoker's Helpline quit tobacco counseling can be accessed at 800-NO-BUTTS.

SAR Helps Hiker! - On the evening of Sunday, January 25, 2015, at approximately 10:00pm, the Mono County Sheriff's Office received a call regarding a hiker with an ankle injury in the White Mountains.

A male hiker, age 19, from Dyer, NV, was hiking in the backcountry of the White Mountains when he injured his ankle jumping off some rocks along the trail, during a camping trip to Crooked Creek. Upon attempting to walk, he was unable to put weight on his ankle and requested assistance to exit the backcountry in the morning.

On the morning of Monday, January 26, 2015, at approximately 6:00am, the Mono County Sheriff's Search and Rescue (SAR) Team was dispatched to aid the injured hiker. SAR Team members responded to the Crooked Creek area. The area was partially covered with snow drifts. With the use of the Mono County Sheriff's Office Ranger, the SAR Team was able to cross the mixed dirt and snow covered terrain. With the aid of an aircraft associated with Deep Springs College, teams located the injured hiker. He was evaluated by an EMT and safely transported out of the backcountry.

Advocate for Local Older Adults? -- If you are age sixty (60) or over, reside in Inyo or Mono County, and are registered to vote, consider applying to be elected to the California Senior Legislature (CSL)! The CSL is comprised of dedicated community volunteers representing all 58 counties in the State. Their primary mission is to gather ideas for model legislation for consideration at the State and Federal levels. CSL members craft these ideas into formal proposals, prioritize and present them to the Legislature or Congress, and advocate for laws that improve the quality of life for aging

Californians.

Senior Senators and Senior Assembly Members voluntarily represent their counties throughout California as members of the California Senior Legislature. The next legislative session of the CSL is in late October 2015 in Sacramento.

Disaster Preparedness Education - It is the American Red Cross mission to help communities prevent, prepare for and respond to disasters. A disaster can strike at any moment; the Red Cross wants to show you and your family how to be ready.



As part of their support services they will be coming to **Mono County in March** to

provide preparedness education programs for our North County communities. The courses they will be offering are:

Prepare U – Bridgeport Indian Colony, Bridgeport, March 6th, 3:00 – 4:00: People should take three actions to prepare for emergencies – get a kit, make a plan and be informed. You'll learn the importance of having an emergency preparedness kit, making a family disaster plan and knowing the types of disasters in your community and the resources available in an emergency.

Senior Prepare U – Antelope Senior Center, Walker, March 6th, 12:00 – 1:00: Designed to help seniors prepare for emergencies, regardless of their physical limitations, this presentation teaches participants how to make an emergency preparedness kit, create a family disaster plan, shelter in place and respond to direction from authorities.

Pillowcase Project (Ages 5-12) – TENTATIVE Antelope Elementary School, Coleville, March 6th, 10:00 – 11:00: The pillowcase project is a psychosocial support program developed to ease fears about emergencies and the evacuations that often accompany them. Children decorate and personalize their own Disney pillowcase and learn ways to pack them with their favorite items from home for easy transport.

In addition to the preparedness education Red Cross will be offering training in Mammoth Lakes. **Adult CPR and First Aid – Department of Social Services, Mammoth Lakes, March 9th, 9:00 – 3:00:** Participants will learn how to recognize and treat adults suffering from breathing and cardiac emergencies, life-threatening bleeding, sudden illness and injuries. Penalties for Not Having Health Insurance – Covered California announced that it is stepping up messaging about the rising penalties for not having health insurance, encouraging Californians without coverage to explore their options and sign up to avoid a big bill at tax time next year. The penalty, known as the "shared responsibility payment," takes effect for 2014, and many who were uninsured will see an impact when they prepare their taxes due in April. However, the penalty rises substantially for 2015, meaning it's important that all uninsured Californians know this and take steps now before open enrollment ends — to avoid significant penalties when they prepare their 2015 taxes due next year. In 2016, the shared responsibility payment for those without health insurance rises even more.

2015 Open Enrollment ends February 15, 2015. Enroll by this date and coverage can begin as soon as March 1. After this date, you can enroll in or change plans for 2015 only if you qualify for a Special Enrollment Period. Check out the attached Open Enrollment Fact Sheet for more information.
