# **LEE VINING** US 395 REHAB PROJECT

The California Department of Transportation (Caltrans) District 9 is planning a resurfacing, restoration, and rehabilitation project to improve safety, accessibility, and mobility along the US 395 corridor through Lee Vining. The community's involvement and ideas are essential to the success of this project!

## WHY IS THIS PROJECT NEEDED?

US 395 through Lee Vining currently faces a variety of safety, accessibility, drainage, and design challenges, including the following:

- Road pavement is nearing the end of its lifespan
- Some sidewalks and curb ramps need upgrades to meet current Americans with Disabilities Act (ADA) standards
- Pedestrian crossings could use enhancements to create safe, accessible, and aesthetically pleasing walkways
- Drainage systems need upgrades in order to capture winter/spring runoff
- Bicycle facilities could be developed to accommodate commuter and recreational cyclists

The Lee Vining US 395 Rehab Project provides the opportunity to improve streetscape design and aesthetics to enhance Lee Vining's **"Main Street"**, providing a range of benefits for community members and visitors alike. Caltrans will work with community members to minimize disruption during peak tourist season.



#### ABOUT THE STUDY AREA

The study area, which covers approximately 5 miles, includes US 395 from SR 120 to Cemetery Road. **The corridor runs through Lee Vining** with commercial uses lining the corridor, on-street parking, and speed limits of 25-30 mph. North and south of Lee Vining, US 395 is a highway with fast-moving traffic.

- Improve the streetscape, landscaping, and visual appearance of the corridor.
- Improve access to retail storefronts.
- Enhance the welcoming gateway to Lee Vining, Mono Lake, and Yosemite National Park.
- Make it **easier for visitors to find local resources** and area attractions.
