It is not an unpopulated part of Crowley, as it has two mobile home parks adjacent, two lodges and a condominium complex complex.

5. "There are potholes in the road."

We have filled in the potholes on the road and said we are willing to keep the road maintained so that is accessible and safe.

6. "We need housing and a local family could rent this full time."

A local family could not rent this home full time because we live here most of the time. The STR permit is so that we can rent it on occasion which is different than having the home with a full time renter.

We specifically bought this property because it was at the end of the cul-da sac and no one can even see or hear when we use and entertain at our home.

Our parking does not bother anybody in the neighborhood and we do not intend to be a nuisance to the community.

We check all the boxes for what is required for an STR permit.

All of the reasons given by the supervisor at the meeting a few years ago were opinions and some were presumed and not factual.

We understand STR permits can be controversial. This is why there are policies in place. Policies typically are in place to avoid personal opinions.

We are not applying for the permit to cause trouble.
