5. Informational/Discussion or Action Items
 - a. Katy will be secretary for tonight's meeting
 - b. Doug Power from MWTC not present
 - c. No representative from USFS. Jeff Ulrich has retired.
 - d. Tim Fesko Supervisor's report. Mill Canyon - closed. MWTC has made a request to the BOS to have access and make some repairs. MOU to have usage without county liability. Only government entities will be allowed to use. There are several new county

employees. Defensible space vouchers are available for the land fill from the fire department. Each voucher is good for 200lbs of refuse from clearing defensible space

a*. Unmet Transmit Needs: John Helm. Bus to Reno M, T, Th, F. Shopping bus Bridgeport to Gardnerville. Dial a Ride. There is a van for a vanpool available but needs 8 people with similar hours and commute routes. Non emergency medical transport reimbursement for those can not afford or cannot drive themselves - offsets gas money. Any questions call 760-872-1901 ext 11.
