Informational / Discussion of Actions:

Caltrans:

Terry Erlwein and Ryan Dermody from Caltrans presented their proposal to close Sonora Pass to large trucks. At present, they are performing outreach to see what parties might be negatively impacted by prohibiting large trucks from attempting to cross over Sonora Pass.

USFS Update:

Jeff Ulrich reporting:

The final EIS for the Bi-state Sage Grouse for draft decision was released on February 7th, 2015. This opens a 60 day objection period before the final decision is released. Overview of changes are limiting OHV hours and grazing in riparian habitat.

The SRS was not renewed

The USFS is hiring summer interns

There will be a bio-char conference in Minden on March 18th, 2015.

On March 25th there will be a Sage Grouse Symposium

MWTC Update:

Doug Powers reported that all courses are in session but coming to an end shortly.

Doug gave a more comprehensive report on the Proposed Communications Systems Upgrade and Supplemental Environmental Assessment (SEA). The project has been shelved since 2010 when it was not funded. It is now funded and will replace an antiquated system that only provides about 40% coverage to the training area. The new system will have one additional site. All sites will be solar powered.
