### New EBT Chip/Tap Card Coming in 2025!

**NEW EBT CHIP/TAP CARD**  
**TAP OR INSERT TO AVOID THE TRAP**  
*Protect yourself from skimming theft. TAP to avoid the trap!*

Chip/Tap lets you pay by tapping the card to the terminal or inserting the chip. You just tap or insert your card, enter your PIN, and that's it! It's a quick and safer way to use your EBT card.



- Use at your local EBT merchant.
- Look for the contactless icon.
- Tap or insert your card and enter your pin.

Check your mailbox often for your new card. You do not need to visit a County office to receive your card, and do not need call to activate your new card. All existing benefits will transfer automatically to your new EBT card and your PIN will stay the same.

- All personal information has been moved to the back of your new card.
- A card expiration date and Card Security Code (CSC) have been added to increase card security.
- The expiration date is for the card only and does not represent your benefits expiration or expungement.

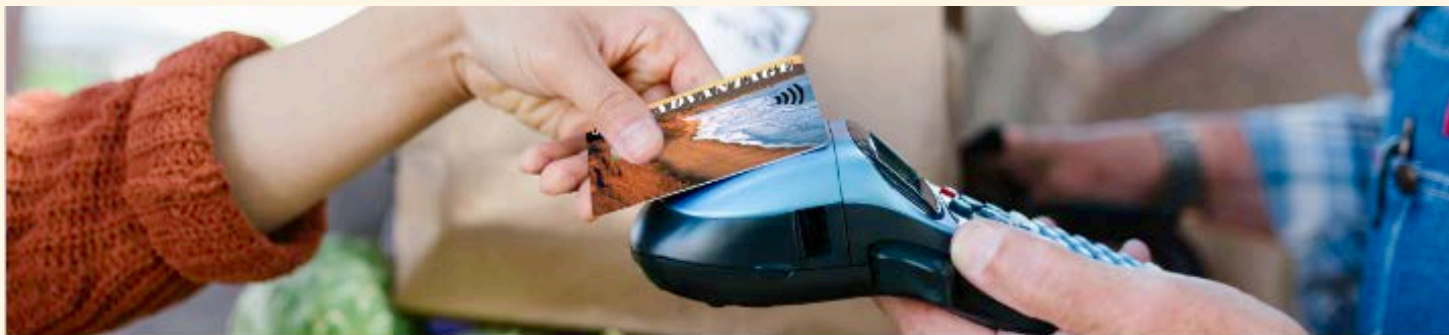

# NUEVA TARJETA EBT DE TOQUE/CON CHIP

Todos los beneficios existentes se transferirán de manera automática a su nueva tarjeta EBT y su PIN seguirá siendo el mismo.

- *Se ha agregado una fecha de vencimiento de la tarjeta y un código de seguridad de la tarjeta (CSC) para aumentar la seguridad de la tarjeta.*
- *La fecha de vencimiento es solamente para la tarjeta y no representa el vencimiento o eliminación de sus beneficios.*

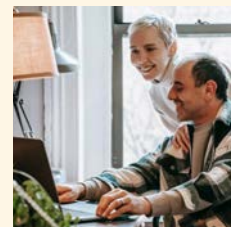

- ♥ Our Home Visiting Program, **Welcome Baby & Healthy Families**, offers early childhood parent education and family support for parents in Mono County with children ages 0 to 5.
- ♥ A series of free visits (at home or another location) with a Parent Educator. Visits focus on learning activities with their child, family well-being, and development centered parenting.
- ♥ First 5 Mono Home Visiting is a Parents as Teachers Affiliate. Parent Educators use the research and evidence-based *Parents as Teachers* program and are certified *Lactation Educators*.
- ♥ Families receive *Parents as Teachers* research and evidence-based handouts at every visit.
- ♥ Participate in developmental screenings using the *Ages & Stages Questionnaire*
- ♥ Learn activities to stimulate your child's motor, intellectual, and social-emotional development
- ♥ Community Resources and Referrals



For pregnant women, families, and babies through preschool, TK, or kindergarten entry that do not qualify for another home visiting program (military or Early Start home visiting)

- ♥ Home Visits once or twice a month, depending on how many stressors your family is experiencing. If you choose to enroll in the California Department of Public Health Home Visiting program through First 5 Mono, you will receive a \$25 grocery card and diapers at every visit.

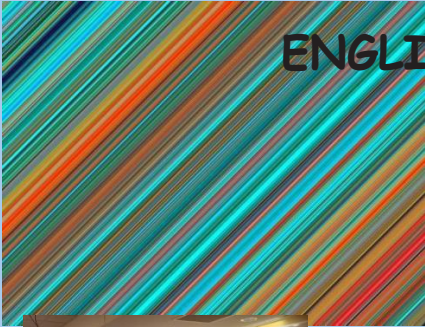

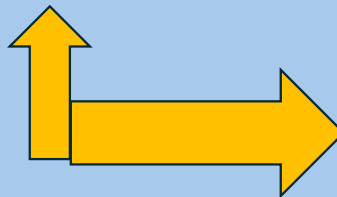

You could be eligible for thousands of dollars in your tax refund when you claim the federal Earned Income Tax Credit and Child Tax Credit

- Identity Protection PIN (IP PIN), if you have one

- Declaraciones de impuestos de 2022 y 2023, si las tiene
- PIN de Protección de Identidad (*IP PIN*), si tiene uno

### Earned Income Tax Credit (EITC) and Child Tax Credit (CTC) Eligibility:

If you don't have children you could qualify for an EITC of up to \$632 if:

**Age:**  
You were between 25-64 years old on December 31, 2024.

**2024 Income:**  
You earned less than \$18,591 (\$25,511 if married).

If you are not a U.S. citizen you could qualify if:

► **EITC:** You, your spouse, and any child you claim have a valid Social Security number (SSN).

► **CTC:** Any child you claim has an SSN. You and your spouse must have an SSN or Individual Taxpayer Identification Number (ITIN).



### Elegibilidad para el Crédito por Ingreso del Trabajo (en inglés *EITC*) y el Crédito Tributario por Hijos (en inglés *CTC*):

Si no tiene hijos, podría ser elegible para un EITC de hasta \$632 si:

**Edad:**  
Tenía entre 25 y 64 años al 31 de diciembre de 2024.

**Ingresos de 2024:**  
Ganó menos de \$18,591 (\$25,511 si está casado/a).

Si usted no es ciudadano estadounidense, podría ser elegible si:

► **EITC:** Usted, su esposo/a y cualquier otro menor que reclame tienen un número del Seguro Social (en inglés *SSN*) válido.

► **CTC:** Cualquiera de los menores que usted reclame tiene un SSN. Usted o su esposo/a debe tener un SSN o un número de Identificación Personal del Contribuyente (en inglés *ITIN*).

## Do I Qualify?

**At tax time, you could owe less in taxes and get money back** with the Earned Income Tax Credit and Child Tax Credit! If you worked in 2024, you may be eligible for these credits.

**Public Benefits:**

- Claiming these tax credits will not change your eligibility for federal benefits like SNAP (food stamps), SSI, Medicaid, cash assistance, or public housing.
- If you save your tax refund, it will not count against federally funded benefit program resource/asset limits for 12 months after the refund is received.

### If you have children you could qualify for the EITC and CTC if:

**Residency:**

- Your children lived with you for more than half of 2024.

**Age – children must be:**

- **EITC:** 18 or under on December 31, 2024 (full-time students can be under 24 and children who have a permanent and total disability can be any age).
- **CTC:** 16 or under on December 31, 2024.

**Income for 2024:**

- **For the federal CTC,** if you earned more than \$2,500, you could claim a credit of up to \$2,000 per child.
- **For the federal EITC,** your earnings must be lower than the following limits:

Number of Children	Single workers with income less than:	Married workers with income less than:	EITC up to:
1 child	\$49,084	\$56,004	\$4,213
2 children	\$55,768	\$62,688	\$6,960
3 or more children	\$59,899	\$66,819	\$7,830

**It's not too late to claim 2021 expanded tax credits!**

Because of the pandemic, the EITC and Child Tax Credit were expanded and made available to more people. That expansion has ended, BUT if you were eligible for the 2021 expanded EITC, the 2021 expanded Child Tax Credit, or any of the three rounds of stimulus checks and didn't claim them, it's not too late! ## ¿Cumplo con los requisitos?

En la temporada de impuestos, ¡usted podría deber menos impuestos y obtener un reembolso con el Crédito por Ingreso del Trabajo (en inglés *EITC*) y el Crédito Tributario por Hijos (en inglés *CTC*)! Si trabajó en 2024, puede ser elegible para estos créditos.

**Beneficios públicos:**

- Reclamar estos créditos tributarios no cambiará su elegibilidad para los beneficios federales, como SNAP (cupones de alimentos), SSI, Medicaid, asistencia en efectivo o vivienda pública.
- Si ahorra su reembolso de impuestos, este no se tomará en cuenta para los límites de recursos/activos de los programas de prestaciones financiados por el gobierno federal durante los 12 meses después de recibir el reembolso de impuestos.

### Si tiene hijos, podría ser elegible para el EITC y el CTC si:

**Residencia:**

- Sus hijos han vivido con usted durante más de la mitad del año 2024.

**Edad - Los hijos deben tener:**

- **EITC:** 18 años o menos el 31 de diciembre de 2024 (los estudiantes de tiempo completo pueden ser menores de 24 años y los hijos con una discapacidad permanente y total pueden tener cualquier edad).
- **CTC:** 16 años o menos el 31 de diciembre de 2024.

**Ingresos para 2024:**

- **Para el CTC federal,** si usted ganó más de \$2,500, podría reclamar un crédito de hasta \$2,000 por menor.
- **Para el EITC federal,** sus ingresos deben ser inferiores a los siguientes límites:
